In late May, the County Administrator and the BOCC Chairperson contacted the Sheriff to request he consider managing Hernando County Animal Services.


At that time, the Sheriff assigned several individuals to a work group to research this project and put together a presentation for the BOCC.

Within a few weeks we gathered a plethora of information by visiting animal shelters in Central Florida (managed both by county entities and Sheriff's Offices), read The Association of Shelter Veterinarians' Guidelines for Standards of Care in Animal Shelters (prepared by UF), and The Best Practice Playbook for Animal Shelters (written by Sara Pizano, DVM,) became certified in the Fear Free Shelter program, toured the Hernando County Animal Services Shelter, met with numerous animal advocates/organizations, and spoke at length with multiple professionals in the field of animal sheltering. In addition, we reviewed both the 2021 and 2024 Operational Consults on the Hernando County Animal Services operation, performed by Maddie's Million Pet Challenge at UF, as well as Standard Operating Procedures and job descriptions from numerous animal shelters in Florida.

## GOALS

#### Our goals would be to:

- Build a strong and sustainable team of individuals (employees and volunteers) who will care for shelter pets as if they are our own;
- REDUCE the intake of animals and INCREASE live outcomes;
- Promptly reunite lost and stray pets with their owners;
- Offer adoption services, foster homes, rescue, rehabilitation, animal training, innovative programs, community resources, and public education.

#### We are dedicated to:

- Meeting the physical and emotional needs of each animal in the shelter;
- Utilizing every resource to prevent healthy and adoptable animals from euthanasia;
   Including the euthanasia of animals for "space;"
- Providing regular compassion fatigue programs for staff and volunteers.

# COMMUNITY ANIMAL RESOURCE CENTER

The shelter would provide <u>resources for pet owners in need</u>.

- Targeted Spay/Neuter Programs
- Community Safety Net Programs
- Low-Cost/No-Cost Vaccinations and Medications
  - Subsidized Private Veterinary Care

As alternatives to surrendering an animal, leaving the finite shelter space for animals with no other options.

# COST SAVINGS AND REVENUE GENERATION

OPPORTUNITIES FOR IMPROVEMENT

- Increased Use of Inmate Labor (Prison Inmates + County Inmates)
  - · Less costly and allows shelter employees to focus on the pets
    - Kennel Work
    - · Dog Training
    - Dog Grooming
    - Kennel/Shelter Maintenance

#### Volunteers

- · We understand and value the importance of volunteers and hope to increase volunteer participation at the shelter
- · HCSO currently has over 300 active volunteers

#### · Pet Licensing

- · No third-party vendor/costs
- Veterinarians

#### Retail

- · Heartworm and Flea/Tick Preventative (lower cost)

# COST SAVINGS AND REVENUE GENERATION

OPPORTUNITIES FOR IMPROVEMENT

- HCSO Grants Specialist researching available shelter grants
- · Pet Food
  - Purchase directly from manufacturer (56% to 74% savings- based on retail pricing)
    - HCAS Current \$43,000/Annual (approximately)
    - HCSO Proposed Less than \$8,000/Annual (approximately)
- Low Cost Vaccination Clinics and Microchipping
  - · On-Site and Off-Site Offerings
    - · Various Vaccinations / Microchip
      - OFFICE STAFF WILL REGISTER MICROCHIP UPON ADOPTION
- Partnerships w/Local Veterinarians and Businesses
  - · Sponsorship of:
    - · Vaccination Clinics
    - · Spay and Neuter Services
    - · Heartworm Treatment
    - · Obedience Classes for Pet Parents


