NOTICE IS HEREBY GIVEN that the Board of County Commissioners of Hernando County Florida, will hold a public hearing on **Tuesday, May 13, 2025, at 9:00 a.m. or soon thereafter**, in the **Hernando County Government Center**, County Commission Chambers, 20 N. Main St, Rm 160, Brooksville, Florida, to consider the following:

AN ORDINANCE AMENDING HERNANDO COUNTY CODE CHAPTER 28, ARTICLE XII, (REGULATION OF THE USE OF FERTILIZERS CONTAINING NITROGEN AND/OR PHOSPHORUS, TO IMPLEMENT REGULATIONS TO MINIMIZE THE NEGATIVE ENVIRONMENTAL EFFECTS CAUSED BY THE MISUSE OF FERTILIZERS) TO CORRECT A SCRIVENER'S ERROR IN SECTION 25-506 (DEFINITIONS); TO AMEND SECTION 28-509 (TIMING OF FERTILIZER APPLICATION); PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR THE REPEAL OF CONFLICTING PROVISIONS; AND PROVIDING FOR AN EFFECTIVE DATE.
