CONCLUSIONS OF LAW:

advised in the record, and based upon competent substantial evidence, the BOCC makes the following specific conclusions of law:

Any requests, uses, variances or exceptions that were requested in connection with this rezoning application but not specifically approved herein are hereby deemed <u>DENIED</u>.
