If proof of rabies vaccinations(s) and/or county license(s) is not provided, you are required to appear before the Special Master if you timely request a hearing.
- ☒ You are required to pay the civil penalty of \$400.00 to Hernando County Animal Services at 19450 Oliver Street, Brooksville, FL 34601 within 20 days of issue date. If you do not pay the civil penalty, you are required to appear before the Special Master if you timely request a hearing.

*** Failure to pay the civil penalty or request an administrative hearing within twenty (20) days after service of this Civil Violation Notice shall constitute a waiver of your right to contest the Civil Violation Notice, and, in such case, the Special Master may enter a default order imposing a civil penalty against you in an amount up to the maximum potential fine per day. You may be liable for reasonable costs of the administrative hearing should you be found guilty of the civil violation. In addition, you may be liable for the County's costs and expenses incurred as a result of investigation, enforcement, testing or monitoring should you be found guilty of the civil violation. Any person who decides to appeal any decision made by the Special Master at the hearing will need a record of the proceedings and, for such purposes, may need to ensure that a court reporter is present at the hearing so that a verbatim record of the proceedings is made.

An administrative hearing may be scheduled by submitting a written request to the Clerk to the Special Master at 20 North Main Street, Suite 462, Brooksville, FL 34601-2850, or by e-mailing cao@hernandocounty.us. The civil penalty may be paid by cash (in person only) or by check, money order or credit card at 19540 Oliver Street, Brooksville, Florida 45601, Tel. (352)796-5062. Requests for hearing and payments must include the Notice No. and SM Case No. Each day the violation continues after the date for correction has run shall be deemed a continuing violation subject to additional civil penalty in the same amount, without the need for additional notices of violation.

Information you need to know about Special Master Hearings

- The case may be presented to the special master even if the violation has been corrected prior to the Special master Hearing;
- You have the right to be represented by an attorney;
- You have the right to present witnesses and evidence;
- Failure of the violator to attend the hearing may result in a civil penalty being assessed; and
- Request for continuances will not be considered if not received in writing by the animal services officer at least ten (10) calendar days prior to the date set for a hearing.
