- The workshop was held in the Town Hall room of Chocachatti Elementary School. Several tripods were utilized to display presentation boards, including the site location, illustrative site plan, and representative architecture. A project fact sheet handout, which is attached, was provided to each attendee.
- Stephen Sposato with LevelUp Consulting provided an outline of the project, including location, context, and design. Additional representatives of LevelUp included Trent Stephenson, P.E., and Eden Cooke, Planner. Steve Henry, P.E., with Lincks and Associates, led responses to questions regarding transportation. The applicant Pulte Homes, represented by Jeff Deason, Ray Aponte, and Shannon Hess, assisted with questions regarding the design of the community, likely product design, and scheduling. Also in attendance for the applicant was Kami Corbet, Esq. with Hill Ward Henderson.
- There were 26 attendees from the community as shown in the attached sign-in sheet.

Public Comment and Questions

- There were several concerns about the amount of traffic on Powell Road, especially in the morning and afternoon with nearby schools. Making left-turns would be challenging given the backups that have been experienced. Additionally, there were follow-up questions on possible improvements to Powell Road, including what would be the responsibility of the applicant and the County.

Answer: The applicant is presently preparing a traffic analysis to assess if offsite improvements, including turn lanes for the project entrance on Powell Road, will be required. This analysis will be provided to County staff for review. In addition, it was acknowledged that school arrival and dismissal are relatively brief but significantly impact traffic.

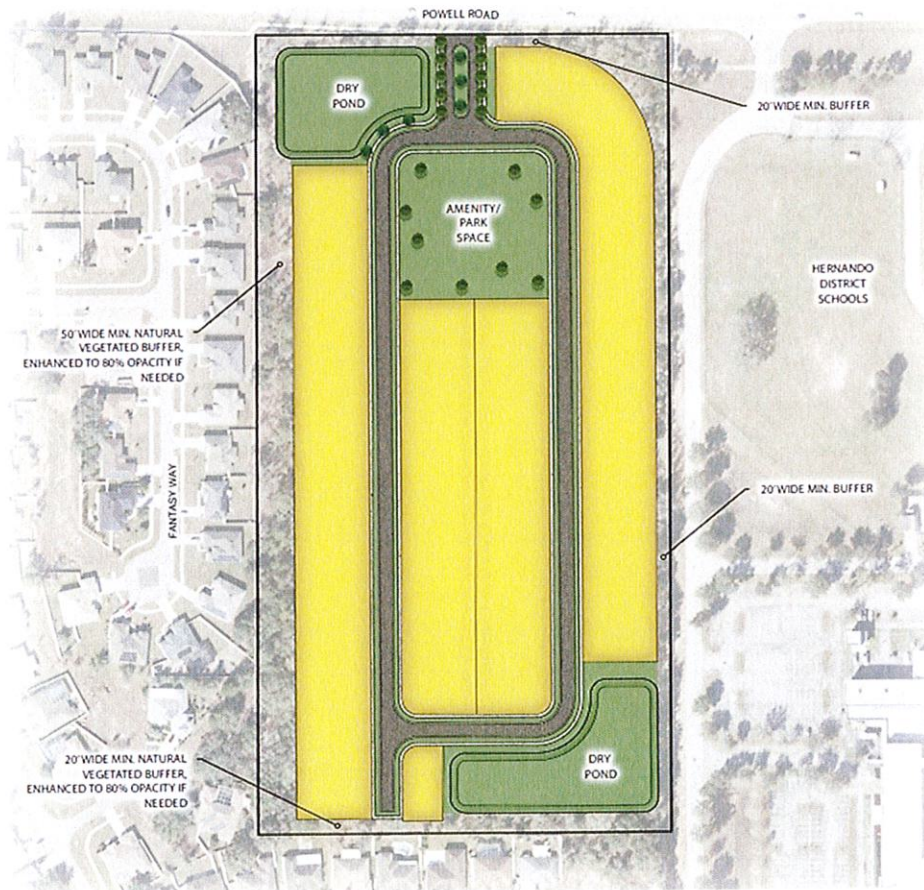
- There was concern about the increase in children and the safety of walking to and from school. It was noted that the streets are not well lit.
- It was noted that high school children illegally turn left on Powell Road out of the school, causing accidents.

- There were questions about the composition of the buffer along the western property line that parallels Fantasy Way and whether a fence would be included.
 Answer: There will be a 50-foot natural vegetated buffer between properties along Fantasy way that will be enhanced to 80% opacity if needed. Fences are not proposed along the property line.
- One attendee asked if there would be an HOA that would include rules on uses, such as the number of dogs and chicken coops.
 Answer: An HOA will be established and include comprehensive restrictions and covenants, including those related to pets.
- It was asked if local contractors would be employed to build the project.
 Answer: Pulte Home intends to use local contractors as much as the availability allows.
- Several attendees asked about the likely project schedule and timing.
 Answer: It is expected that site construction will be a 6-month process that could begin as early as March /April 2023, followed by 18 months to construct the homes.
- An attendee expressed concern about the negative impacts on housing values.
- There was a question about the potential disturbance of the memorial located within the right-of-way of Powell Road.
 Answer: The applicant stated the memorial would not be disturbed.
- An attendee expressed concern about pest mitigation during the construction phase, given that the property is currently undeveloped and vegetated.
- A resident was concerned about sound from construction and the proposed 68 single family homes, especially since there is already noise associated with nearby schools.

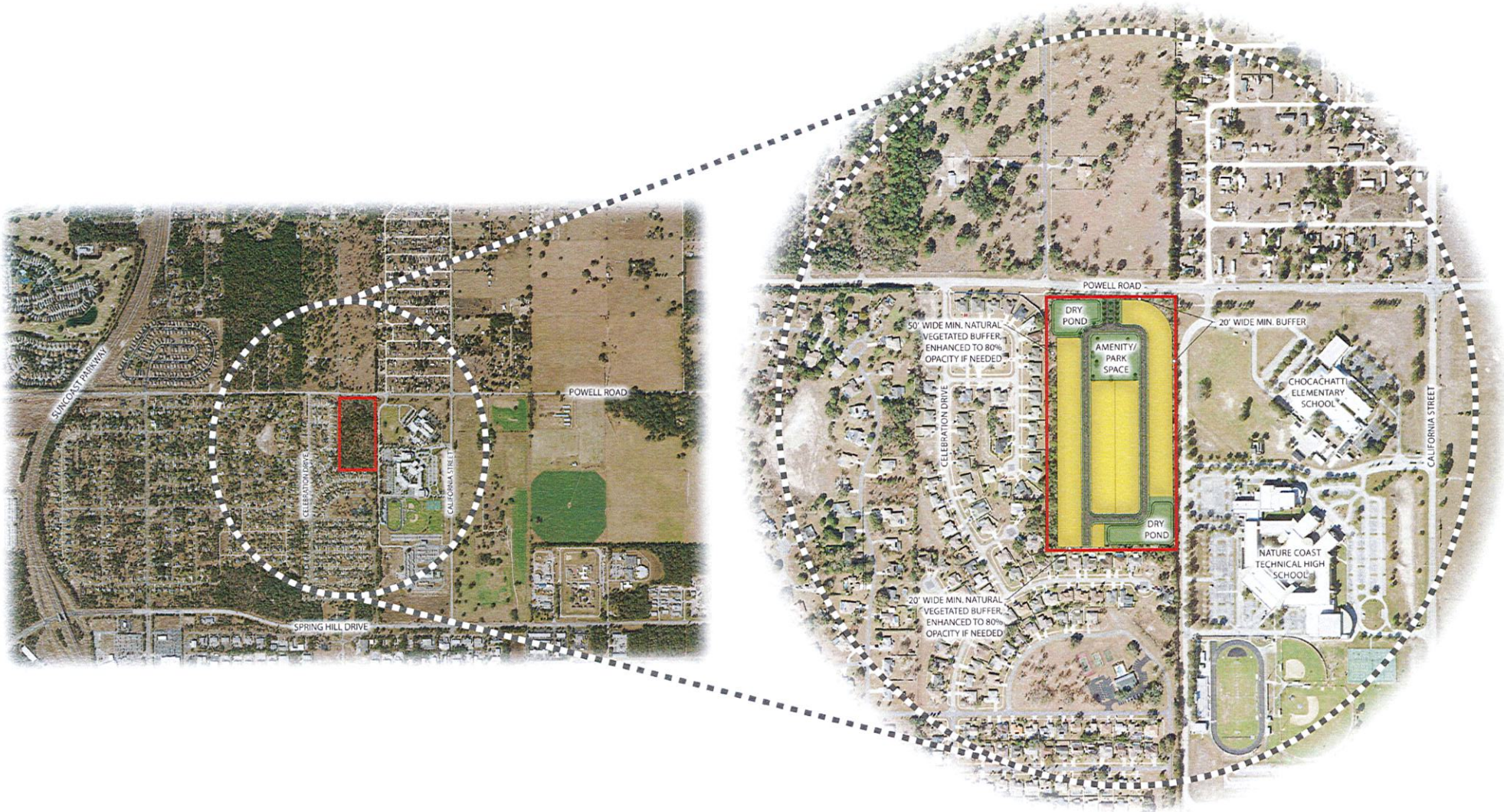

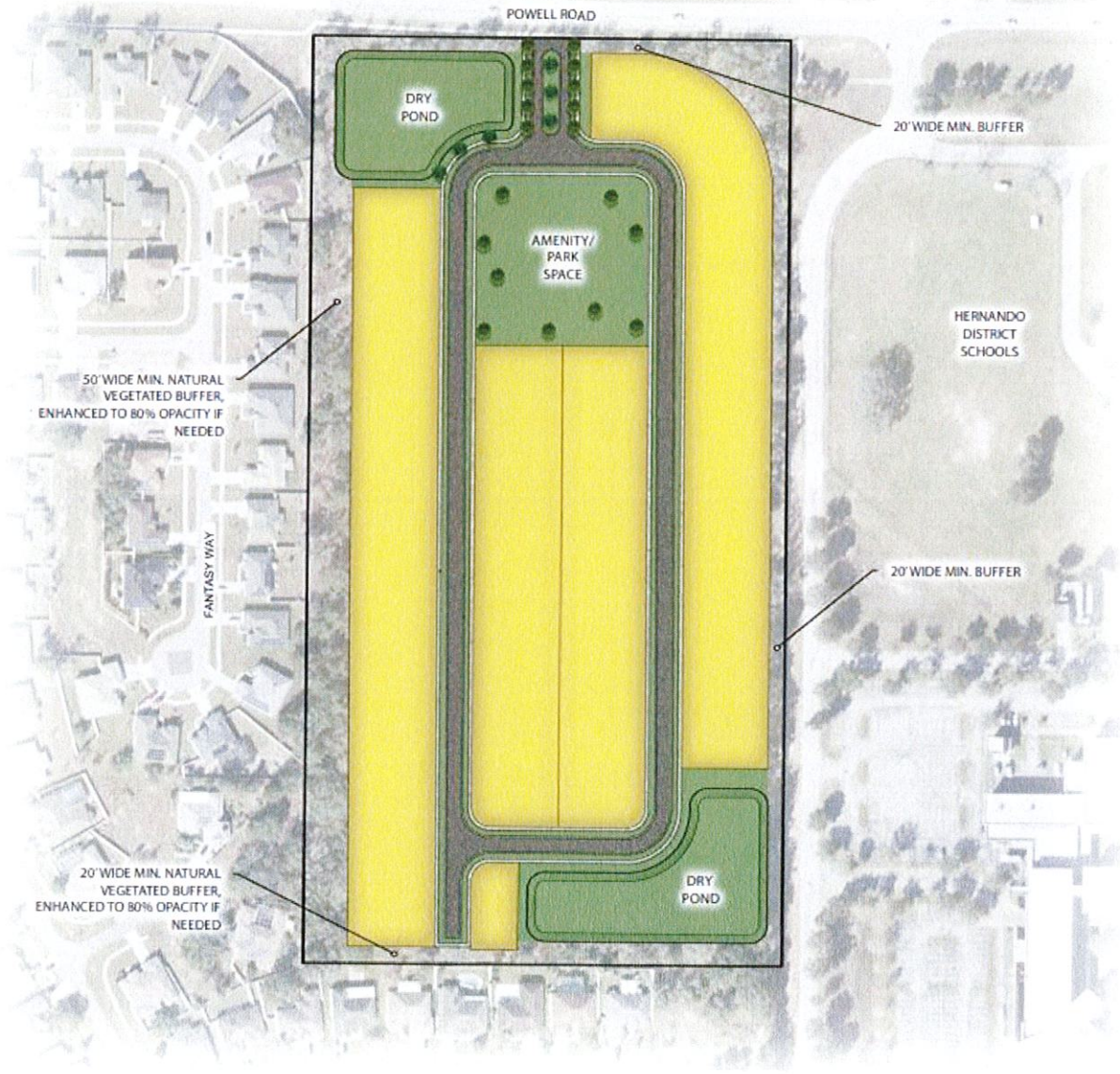

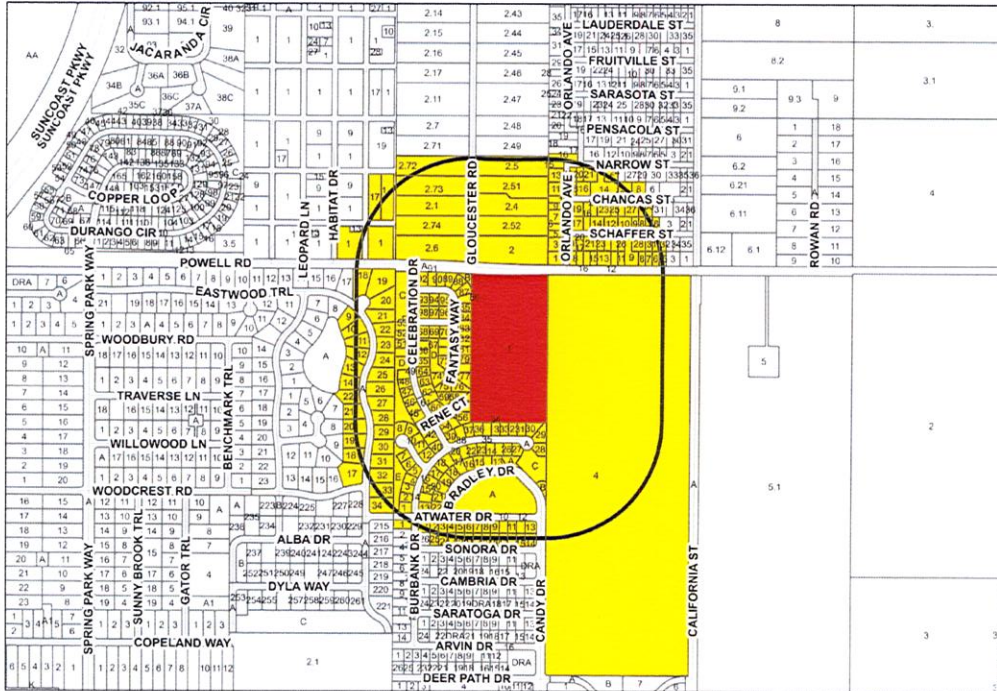
