# METHODOLOGY, TECHNICAL ABILITY AND APPROACH

As a core principle, we aim not only to provide essential resources and tools but also to empower your teams with the knowledge and skills to thrive in even the most challenging circumstances. Our commitment to Hernando County includes:

### Approach

iParametrics will manage and distribute the 49 Temporary Housing Units (THU) that Hernando County, has acquired as a donation from the Florida Department of Emergency Management (FDEM). These THUs will be used in support of owner occupants who sustained substantial damage to their dwelling as a result of either Hurricane Helene or Milton in 2024. The THUs will be used to house residents on the property lot of their damaged dwelling if space permits and utility connections are available.

This program will provide eligible households with the use of THUs when other temporary housing options are not available or accessible due to lack of reliable transportation, geographic location, accessibility, or other critical need as determined and verified by the case management team.

The iParametrics team understands this program has been designed and is intended to meet a specific temporary housing need for survivors who have exhausted all other potential housing resources from FEMA, HOPE Florida, and other local assistance programs. Survivors will be assessed for the program based on the eligibility criteria outlined by the County.

Survivor eligibility will be evaluated through the disaster case management intake and eligibility assessment. Survivors utilizing this sheltering resource provided by the county for their temporary housing need will demonstrate ongoing progress towards achieving the repairs necessary to their dwelling with resources obtained from various other long-term recovery agencies.

### Program Management

iParametrics will apply a structured and scalable Program Management Office (PMO) model to oversee all aspects of Hernando County's Post-Disaster Housing Pla aspectsn. Our PMO will ensure that resources are effectively deployed, compliance is maintained, and survivor needs are met promptly.

To ensure effective execution, iParametrics will establish a Program Governance Structure that aligns with the Disaster Housing Working Group (DHWG) and the Hernando County Board of County Commissioners (HCBOCC). Our governance structure will include:

- Program Manager: Oversees all aspects of the program, ensures alignment with County objectives, and reports directly to the DHWG. The Program Manager will also ensure stakeholder coordination with FEMA, FDEM, Hernando COAD, Hernando LTRG, and private sector partners as necessary and appropriate.
- Logistics Manager: Lead implementation teams for site feasibility assessments, management of skilled trades, and permitting for the installation and utility hook-ups of THUs on survivor properties.
- Disaster Case Managers: Work directly with survivors to complete the intake and eligibility process. The DCM team will work with all residents of Hernando County to ensure they are informed of the various long-term recovery resources available and will work with survivors to determine initial eligibility for a THU. The team will prepare all case files and complete the necessary verifications to present case summaries to the DHWG for final eligibility determination. Once determinations are made by the DHWG, the DCM team will continue to work with survivors through their long-term recovery to ensure they remain compliant with the terms of their grantee agreement with the County.
- Finance and Compliance Managers: Oversee and manage all billing and invoicing related to the PMO for the Hernando County post-disaster housing program.

### **DISASTER CASE MANAGEMENT & ELIGIBILITY**

Our approach ensures data-driven case management to track survivor housing needs and assign the most appropriate housing solution. The disaster case management process will be implemented by iParametrics using the County's established Vision Link database. Our team will ensure that ongoing data collection and entry are precise and consistent to ensure efficient service delivery to survivors who need this resource. Our team's advanced knowledge and comfort with using Vision Link in disaster case management enables us to provide the County with accurate and reliable data reporting. The iParametrics team has a strong working relationship with Vision Link's providers. Our relationship and trust with Vision Link means we can request technical support and changes to support the best system functionality on behalf of the County. The Vision Link team has previously coordinated this

# Temporary Housing Logistics (THU Program)

iParametrics will oversee all logistical coordination for the THU program, ensuring seamless acquisition, placement, and transfer of donated Temporary Housing Units (THUs) from the County to survivors.

### **KEY RESPONSIBILITIES:**

- Requesting & Receiving THUs: Coordinating with FDEM Recovery Branch via WebEOC mission requests should the need for additional units be identified and approved by the County.
- **Legal Execution:** Ensuring proper execution of the Grantee Agreement, Title transfers, and compliance with the local permitting requirements to include renewals as needed.
- Site Assessment & Utility Coordination: Conducting pre-placement site surveys to verify floodplain restrictions, permit requirements, and utility availability.
- **Final Grantee Selection:** Utilizing a transparent scoring matrix to award THUs to eligible survivors in accordance with DHWG-approved selection criteria.
- **Contractor Oversight:** Developing and executing contractor and skilled trades support in THU transportation, setup, and utility hookups.

### STAKEHOLDER & COMMUNITY COORDINATION

iParametrics will facilitate multi-agency collaboration to ensure seamless coordination between County, State, and Federal stakeholders.

- **Regular Working Group Meetings:** iParametrics will assist the DHWG in scheduling and facilitating coordination meetings to monitor program effectiveness.
- Community Outreach & Survivor Support: Implementing public awareness campaigns to educate survivors on available housing options and eligibility criteria.

We are prepared to support the County in person or virtually, depending on the needs of the County's recovery efforts and the ability to provide a safe working environment for our overall team. Traditionally, in-person service delivery is the best model, as you can look key stakeholders in the eye, read body language, and directly work issues.

#### HAZARD MITIGATION PROGRAM

The best time to identify hazard mitigation opportunities is during site visits and/or before construction begins. It is imperative that Hernando County visit damaged sites together with the iParametrics team, the State, and FEMA, when possible. Once on-site, the damages and the mitigation opportunities that exist can be assessed in real-time. At that point, capturing photos and measurements, along with any documented damages, is paramount to demonstrate that the damage occurred as a result of the specific disaster event.

On Day One, our team will focus on laying the groundwork for a structured and proactive approach to supporting hazard mitigation under FEMA's Sections 404 and 406, including drafting Hazard Mitigation Proposals (HMPs), conducting Benefit-Cost Analysis (BCA), and preparing grant applications for FEMA's 404 and 406 programs. Clear communication, data gathering, and strategic prioritization will ensure a smooth

start to the long-term recovery and mitigation process. We will focus on:

- Data collection: Gathering critical data to identify opportunities for hazard mitigation.
- **Opportunity assessment:** Identify and prioritize areas where hazard mitigation can reduce future risks.

#### SHORT-TERM FOCUS:

In the short-term, we will work on developing hazard mitigation proposals and start drafting proposals for these projects. We will begin outlining the framework for initial proposals, identifying key mitigation measures that address damaged elements and prioritizing urgent or high-impact mitigation measures for immediate action. We will then coordinate for future grant applications, including planning next steps and reviewing existing local Hazard Mitigation Plans and collecting the data needed to conduct the applications, BCAs, and cost estimates.

### LONG-TERM SUPPORT:

The iParametrics team is comprised of experts in the area of Hazard Mitigation Planning and application development. Our team has applied for and captured over \$7 billion in funding for resilience planning and infrastructure projects, including millions in similar communities hit hard by hurricanes. Once projects are defined and decided upon, and short-term goals are met, we will begin the long-term work of applying for hazard mitigation funding through a variety of funding sources. We will use the following steps to create these applications:

- Project Description and Scope of Work: Coordinate with Hernando County to
  finalize a detailed scope of work, including planning, design, and construction of the project
  and narrative for the need.
- Project Location and Mapping: Develop project location maps using Geographical Information Systems (GIS). Our in-house data analytics team can create these maps to understand the project needs.
- BCA Development and Finalization: Conduct a BCA using FEMA's BCA Toolkit Version 6.0.0 or the relevant benefit-cost calculation software for the proposed permanent solution and obtain a benefit-cost ratio.
- Project Budget and Schedule: Develop cost estimates in accordance with costestimating guidelines of the relevant granting agency. The schedule will reflect the appropriate time needed to complete the proposed project within the context of the grant period of performance deadline.

- BABAA and Other Federal Provisions (as required): Ensure compliance with
  federal statues, including the Build America, Buy America Act (BABAA), which requires all
  federal agencies to ensure that no federal financial assistance for infrastructure projects is
  provided unless all of the iron, steel, manufactured products, and construction materials
  used are produced in the United States.
- Environmental and Historic Preservation (as required): Conduct a desktop review
  of the project site as it pertains to 44 CFR Part 10 to demonstrate that the proposed
  project minimizes harm to the environment, cultural resources, and at-risk populations.
   We will also send review and concurrence requests required by 44 CFR Part 10 to any
  relevant federal, tribal, state and local agencies.
- Post-Submittal Requests: Review requests as they come to assure that funding is awarded because of application completeness, compliance, compelling narrative, and comprehensiveness.

The best time to identify hazard mitigation opportunities is during site visits and/or before construction begins. It is imperative that Hernando County visit damaged sites together with the iParametrics team, the State, and FEMA, when possible. Once on-site, the damages and the mitigation opportunities that exist can be assessed in real-time. Once construction is complete, the opportunity to mitigate is lost; therefore, before construction begins, we will provide an experienced hazard mitigation specialist knowledgeable in both 404 and 406 mitigations to identify what can be done to each specific building/structure to ensure it is rebuilt with resilience in mind.

FEMA has the authority to provide PA funding for cost-effective hazard mitigation measures for facilities damaged by the specific disaster incident. FEMA also provides hazard mitigation under its Hazard Mitigation Assistance (HMA) programs, which is administered by FEMA Federal Insurance and Mitigation Administration. Our project staff are knowledgeable and experienced in the eligibility criteria, procedures, timelines and conducting benefit-cost analysis (BCA) for the implementation of the hazard mitigation measures funded under HMA programs and the hazard mitigation measures funded under the PA Program.



We will identify mitigation measures that are cost-effective and beneficial to enhance facilities in a manner that minimizes future damages.

Lastly, our team will also seek mitigation opportunities through the Flood Mitigation Assistance program (FMA) along with the Pre-Disaster Mitigation Program (PDM).

The team will assist Hernando County with recovering costs from other Federal and State agency programs. iParametrics will work with the County and additional stakeholders in obtaining disaster-related funding from CDBG, Hazard Mitigation, HUD, and other programs applicable to the specific damages. Also, our staff will research the availability of any Federal or State programs currently in place or recently proclaimed to advise Hernando County on all applicable funding opportunities available.

While knowledge of the requirements surrounding these grants is a key element in a successful application, it is equally important to understand how these different grants can be layered and leveraged to maximize the funding received. For example, iParametrics Project Manager Shanti Smith-Copeland, FPEM, CEM, worked with the City of Bonita Springs, Florida, after Hurricane Irma to layer HMGP, CDBG-DR, infrastructure grants, and FEMA Flood Mitigation Assistance funding to maximize all available mitigation funding after Hurricane Irma. This included three FEMA HMGP applications, totaling \$10 million, a \$5 million CDBG-DR Home Buy Out grant, and FMA grant. By understanding the timeline of how grants are released after a disaster and grant requirements of these funding sources, Shanti was able to progressively layer the funding opportunities as the grant application windows opened to maximize the mitigation funding available across the community.

iParametrics has supported the **FEMA Public Assistance (PA) Program** for the past 21 years as a subcontractor to the Fluor Corporation. Through the PA program, we support federal disaster grant assistance, provide emergency management and security planning services, and provide custom training and exercises. We serve as an extension of our clients' staff, working to plan, prepare, and support emergency management and homeland security services, including bid specifications and proposal preparation and technical support, as needed.

Since 2019, iParametrics has supported the **Town of Sneads, Florida**, with their long-term recovery efforts from Hurricane Michael. We guided Town leadership in their pursuit of FEMA PA, 406 Mitigation, and Hazard Mitigation Grant Program (404 Mitigation) funding. To date, we have identified additional eligible damages totaling nearly \$2 million, completed multiple HMGP (404) grant applications, identified additional 406 hazard

- mitigation opportunities to enhance overall community resilience, and coordinated with insurance to increase the total cost recovery and avoid potential duplications of benefits.
- We are working with John Hopkins All Children's Hospital to complete applications for the HMGP to harden the envelope of their outpatient facilities across six counties impacted by Hurricane Ian. Once approved, we will manage the grant funds to ensure compliance through closeout. Additionally, we assisted with developing their project worksheets as part of their Hurricane Ian Recovery process.
- We are working with the Greater Naples Fire District to create applications for HMGP funds to harden fire houses impacted by Hurricane Ian. Once these applications are approved, we will also manage the funds to provide these improvements. We are managing CDBG-DR funds to relocate a firehouse out of a floodzone.
- We are also working with the City of Naples as a sub consultant to rebuild the Naples Pier. We are assisting the city and our partner on the use of FEMA PA to rebuild a multimillion dollar pier that is historic district in downtown Naples, FL. This pier was destroyed during Hurricane Ian and is a critical part of the tourism and the community in Southwest Florida.

#### ADDITIONAL RECOVERY CLIENTS


Management and Response Plan to assist the community in the prevention, management, and resolution of emergency and crisis situations and training to support the plan. We created in-person training for the Senior Leadership Team while providing a SCORMcompliant online course for over 6,000 employees to be deployed in the client's Learning Management System. Using several workshops with County leadership and staff, we performed a community-wide crisis management gap analysis using a variety of federal guidance, best practices, and the Emergency Management Accreditation Program (EMAP) and standards. As part of the County's Emergency Operations Plan (EOP), a Strategic Plan was developed to provide day-to-day, high-level context for crisis planning, and an Operational and Tactical Plan was developed to provide the specific steps responders would take during a crisis event. To support the updated EOP roll out, a series of training workshops and exercises were provided to more than 60 senior leaders within the client's operations. This training focused on key roles and actions these leaders would need to implement during a crisis. Concurrently, our team designed an online awareness level training for the client's employees to educate them on individual roles and responsibilities during a crisis event. In March 2020, in response to the COVID-19 pandemic, the community mobilized the plan in support of pandemic mitigation and response activities.

- iParametrics supported the **Georgia Mountain Regional Commission (GMRC)**, which is made up of 13 counties and 38 municipalities in northern Georgia, in regional recovery efforts to expedite financial recovery from the pandemic and minimize impacts from future disasters. We advised GMRC and its member counties and cities on how to effectively use the CARES Act funds to create economic development and recovery opportunities. We provided the Commission with a Pandemic Transmission Analysis and Planning Toolkit, comprehensive economic development strategies, County Economic Recovery Plan Template, and in-person and online training. iParametrics served as a liaison and coordinator for GMRC to build relationships with businesses and governments and support these local economies to recover from the pandemic shutdown by creating action plans, needs assessments, and toolkits to assist their communities with recovery efforts. The City issued an Emergency Declaration to help address work stoppage and continuation of critical services, including wastewater, sewer, and transportation services to the community. Within 24 hours, elements of the iParametrics Incident Management Team (IMT) mobilized to support the City's planning and preparation process. Staff members assumed the role of Senior Advisor to the Incident Commander, Planning Section Chief, Incident Command System Situation Unit Leader (SITL), and Logistics Chief.

In October 2018, Hurricane Michael ripped through the Florida panhandle, destroying everything in its path and leaving many without homes and power. The Town of Sneads put out a request for comprehensive disaster recovery services and financial and grant management support.

### **TASK**

In early 2019, the Town of Sneads selected iParametrics to help recover from Hurricane Michael's devastation. Our team coordinated all FEMA Public Assistance grant responsibilities and identified opportunities for CDBG-DR and EDA funding.

### **ACTION**


The iParametrics team provided expert guidance to the Town's leadership as they pursued FEMA Public Assistance, 406 Mitigation, and Hazard Mitigation Grant Program (404 Mitigation) dollars. We provided multiple subject matter experts who were engaged throughout the process, providing the Town with consistent support through multiple FEMA staff changes (6 PDMGs and 5 TFLs).

### **RESULT**

Major items accomplished included:

- · Identified additional eligible damages totaling nearly \$2 million,
- Coordinated with insurance to increase cost recovery and avoid a potential duplication of benefits,
- Coordinated and oversaw all site visits.
- Identified and recovered volunteer time as well as donated resources to reduce local disaster cost share,
- Identified additional 406 hazard mitigation opportunities to enhance community resilience,
- The Town received \$750,000 in HMGP (404) and CDBG-DR funding.





## PRICING PROPOSAL ASSUMPTION

The pricing proposal submitted in the OpenGov portal is inclusive of the following program assumptions.

- Falon Alo will commit 80% or more of her time to this program. Portal limitations did
  not allow for a precise calculation of her anticipated hours on this program. Falon's hours
  will be billed to match her actual hours worked. 80% of Falon's time commitment would
  equate to 1,664 hours.
- Alexis Balde will commit 100% of her time to this program. Alexis is currently a part-time employee of iParametrics. The maximum hours she would commit to this program would be 1,040 hours annually.
- Direct project costs related to the delivery, set-up, utility connections, and permitting fees
  are based on current market rates as determined during the early implimentation phase
  of this program. The County has expressed a desire for these costs to be the responsibility
  of grantees being awarded the THU. Fees related to the delivery and installation of the
  THUs will not be billed back to the County when they are paid by the grantee or with
  other agency funds.
- The United Way of Hernando County has committed approximately \$80,000.00 of their Hurricane Relief funds to cover these costs when deemed nescessary and documented accordingly via the disaster case management process.
- The disaster case management team will leverage existing County programs such as SHIP
  Disaster Repair assistance to cover related costs where necessary and applicable. The
  iParametrics team is coordinating closely with the County's Department of Housing and
  Supportive Services team to coordinate this process.
- To date, as of the writing of this proposal, iParametrics acknowledges that 17 site
  inspections have been completed. The pricing proposal reflects the quantities provided
  in the Request for Proposal due to portal limitations with the pricing proposal formulas.
  Should iParametrics be awarded the contract for this work, an updated budget will be
  provided upon request to reflect the current number of THUs remaining in the County's
  possession.
- The pricing proposal table in the portal would not allow for the creation of additional labor categories or the editing of job titles. Please note the roles as described in the Key Personnel section of this proposal reflect the intended staff for the program based on existing experience with the implimitation of this program. Our team is happy to discuss those roles if requested by the County.
