Description of Proposed Use

Application for a Special Use Exemption Permit to establish a private use airport runway on private property which is zoned agricultural.

FAA approval has been obtained. Application Form 7480-1 (Notice for Construction, Alteration and Deactivation of Airports) was submitted to the FAA (Federal Aviation Administration), and a study was conducted by OE/AAA (Obstruction Evaluation / Airport Airspace Analysis). The application was approved by the FAA and a copy of the approval letter is included with this application.

No construction will be required, as the proposed turf runway will use the existing grass surface which is well drained and suitable for the intended use. The property is approximately 330' x 1295' (9.8 acres) and the proposed runway area will be 1230 feet long by 50 feet wide (1.4 acres), positioned along the South side of the property, and the orientation will be East/West (runway heading 9/27).

Estimated activity is 20 takeoff and landing operations per month of small private aircraft.

There are no structures on the property, the perimeter is fenced, and access is by a private drive easement on the South side and through the adjacent property on the North side, which is owned by the applicant.
