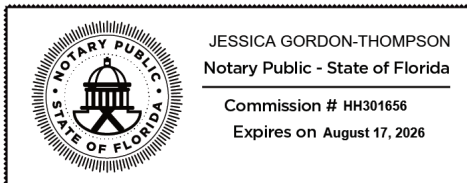

NOTICE IS HEREBY GIVEN that the Board of County Commissioners of Hernando County Florida will hold a public hearing on **Tuesday, February 3, 2026, at 9:00 a.m. or soon thereafter**, in the Hernando County Government Center, County Commission Chambers, 20 N. Main St, Rm 160, Brooksville, Florida, to consider the following:

AN ORDINANCE OF HERNANDO COUNTY, FLORIDA, AMENDING APPENDIX A, ARTICLE V, SECTION 4 OF THE HERNANDO COUNTY CODE, RELATING TO THE CONDITIONAL USE PERMITS ALLOWABLE WITH ADMINISTRATIVE OFFICIAL APPROVAL AND BACKYARD CHICKENS; AMENDING THE TYPES OF ALLOWABLE BIRDS PERMITTED; AMENDING THE NUMBER OF BIRDS PERMITTED BY PARCEL SIZE; AMENDING THE COOP STRUCTURE SIZE THAT REQUIRES A BUILDING PERMIT; PROVIDING FOR NO MINIMUM LOT SIZE ALLOWED; PROVIDING FOR NO TIME PERIOD FOR THE LENGTH OF TIME A PERMIT IS ISSUED; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR THE REPEAL OF CONFLICTING PROVISIONS; AND PROVIDING FOR AN EFFECTIVE DATE.
