**SECTION 1.** The above-described portion of Right-of Ways is hereby vacated, abandoned, discontinued, and closed, and the Board of County Commissioners of Hernando County, Florida hereby renounces any right of the County and the public in and to the land embraced in and constituting said portion of Right-of-Ways.
