FIFTH AMENDMENT TO AVIATION GROUND LEASE (The "FIFTH AMENDMENT") BETWEEN HERNANDO COUNTY AND RAYTHEON COMPANY

THIS IS AN AMENDMENT dated April 1, 2015 to the Aviation Ground Lease dated April 1, 2003 between Hernando County, a political subdivision of the State of Florida, whose address is 20 N. Main Street, Room 263, Brooksville, FL 34601 (the "Lessor") and Raytheon Company, whose address is 870 Winter Street, Waltham, MA 02451(the "Lessee").

WHEREAS, the Lessor and the Lessee entered into the Aviation Ground Lease dated as of April 1, 2003, and as recorded in Official Records Book 1650, Pages 454 through 483, of the Public Records of Hernando County, FL (the "Ground Lease") for the lease of certain real property described as:

9,000 SF (mol) of the Hernando County Airport land, described as shown in Exhibits A1, A2 & A3, attached to the **Ground Lease**, as said Exhibits were recorded in the aforesaid Official Records Book at Pages 468 through 470; and,

WHEREAS, the Ground Lease was scheduled to expire on March 30, 2007 and the Lessee and the Lessor agreed to an Amendment to the Aviation Ground Lease (the "First Amendment") extending the Ground Lease for an additional two (2) years running from April 1, 2007, and ending on March 30, 2009; and, (the "Second Amendment") extending the Ground Lease for an additional two (2) years running from April 1, 2009 and ending on March 30, 2011; and, (the "Third Amendment") extending the Ground Lease for an additional two (2) years running from April 1, 2011 and ending on March 30, 2013; and, (the "Fourth Amendment") extending the Ground Lease for an additional two (2) years running from April 23, 2013 and ending on March 30, 2015; and,

WHEREAS, the Ground Lease and the First Amendment, Second Amendment, Third Amendment and Fourth Amendment are hereinafter referred to collectively as the Ground Lease; and,

WHEREAS, the Ground Lease is scheduled to expire on March 30, 2015 and Lessee desires to extend the Ground Lease for two (2) additional years; and,

WHEREAS, the Lessee has duly performed under the Ground Lease and is not otherwise in breach of said agreement; and,

WHEREAS, the Lessee has timely advised the Lessor of its intent to renew the Ground Lease.

NOW THEREFORE, in consideration of mutual covenants herein contained, the parties agree as follows:

- 1. The Lessee and the Lessor agree that the Ground Lease is hereby extended for an additional two (2) years commencing on March 31, 2015, and ending on March 31, 2017 (the "Fifth Extended Term").
- 2. The Monthly Rent during the Fifth Extended Term shall be \$135.00.
- 3. Except as provided above, all other terms, conditions and covenants of the Ground Lease shall remain in full force and effect.
- All capitalized terms not otherwise defined herein shall have the meaning ascribed to 4. them in the Ground Lease.
- This Fifth Amendment shall be recorded in the public records of Hernando County; the 5. Lessee shall pay the cost of recording.
