Our Fire and Rescue Department is interested in piggybacking on your EMS Medical Supplies Contract. I was able to locate most of the information I need; however, the 107-page document available on your website does not appear to be the fully executed contract. Several pages are either blank or contain incomplete documentation from the awarded vendors.

Could you please provide the fully executed contracts for the three awarded vendors, along with the proposals they submitted?

Additionally, our department is exploring the possibility of negotiating the pricing percentages. Upon review, I did not find any provisions in the ITB that allow for pricing negotiations by outside entities. As I am not entirely familiar with your documentation, I wanted to confirm whether such flexibility exists and ensure I haven't overlooked anything.
