Proposal: The request is to rezone the property from R1A to AR2. The rezoning request is so the owner can consider privacy fencing in the front of the property and owning livestock in the future. Several adjacent properties have been zoned AR2. The property is currently 3.1 acres and according to the GIS map, located in a rural unincorporated zone.
