## 2022 GRANT RECIPIENTS - PROGRAM REVIEW

The Hernando County Sheriff's Office and the Fifth Judicial Circuit Court reviewed the programs for which the 2022 funding had been used by their Agencies. Due to delays in finalizing the grant agreements, the HCSO has the car cameras on order, but they have not yet been installed. They anticipate expending all grant funds by September 30. The Fifth Judicial Circuit Court is still working through revisions on the grant agreement with FDLE. They anticipate spend-down to begin once the agreement is finalized.

## 2023 BYRNE JUSTICE ASSISTANCE GRANT ALLOCATION - \$64,081.00

Preliminary Funding Applications had been submitted by the following agencies:

- Fifth Judicial Circuit Court Administration - \$16,020.25 for the Hernando County Adult Drug Court Program; and
- Hernando County Sheriff's Office - \$48,060.75 for the purchase of in-car cameras for patrol vehicles.

It was determined that there was no need for a grant review subcommittee as all SAPAB attendees agreed on the proposed allocation and the preliminary applications did not exceed the award amount.
