
Dear Commissioners,

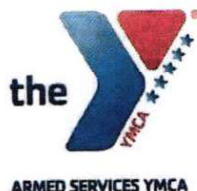

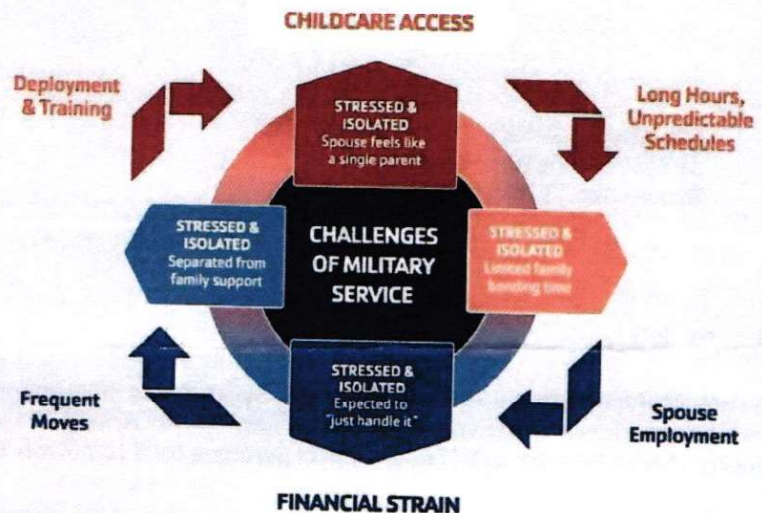
