Good morning,

We are working on a CAD replacement project that will require a special draw from the county along with funds from the fire department and city of Brooksville Fire. This project will cross fiscal years so I want to get your opinion on how I would like to handle the accounting for the funds. The funding is for a special project, not fees for service which are returned each year. I would like to set up a cost center in our Fund 75 (special revenue fund) that holds all of our grants and donations.
