NOTICE OF PUBLIC HEARING TO IMPOSE AND PROVIDE FOR COLLECTION OF SOLID WASTE DISPOSAL SPECIAL ASSESSMENTS

Notice is hereby given that the Board of County Commissioners of Hernando County, Florida, will conduct a public hearing to consider the reimposition and increase of annual solid waste disposal special assessments for the provision of solid waste disposal services within the boundaries of the Hernando County Solid Waste Disposal and Resource Recovery System District, which includes all real property located in the County, for the calendar year beginning January 1, 2025, and future years.

The hearing will be held on Tuesday, July 9, 2024, at 9:00 a.m., or as soon thereafter as possible, in the County Commission Chambers, located in the Hernando County Government Center, 20 North Main Street, Room 160, Brooksville, Florida, for the purpose of receiving public comment on the proposed assessments. All affected property owners have a right to appear at the hearing and to file written objections with the Board of County Commissioners within 20 days of the first publication of this notice.

If a person decides to appeal any decision made by the Board of County Commissioners with respect to any matter considered at the hearing, such person will need a record of the proceedings and may need to ensure that a verbatim record is made, including the testimony and evidence upon which the appeal is to be made.

In accordance with the Americans with Disabilities Act, persons with disabilities needing a special accommodation or an interpreter to participate in this proceeding should contact the County Administrator's Office, 15470 Flight Path Drive, Brooksville, Florida 34604, or telephone (352)754-4002, at least three (3) days prior to the date of the hearing. If hearing impaired, please call 711 for assistance.

The assessment for each parcel of property will be based upon each parcel's classification and the total number of assessment units attributed to that parcel. The following tables reflect the proposed solid waste disposal assessment schedules.
