Ok thanks so much for all your time and consideration the past few months. Mrs. Hare you have been a pleasure. Please add this to the hearing agenda please.

I am disabled and they are proposing a very low hourly number. I'm not supposed to be doing much labor at all and I don't think I can perform the hours that I was offered to do. The board and staff already knew I was disabled from the beginning of these hearings.

I think I want to ask the board to just forgive this CRLO total balance at this point. I can't volunteer 8 hours a week I know my body can't handle it.

The only reason I asked for community service hours was to get this lien taken care of so I can restore my civil rights through the clemency board in Tallahassee and I don't have ways to put out of pocket due to being indigent. I keep getting denied the right to restore my civil rights due to this CRLO balance. I have been denied 3x now from the Clemency Board because of this lien order which they say is not part of my case but it is if it wasn't I would have been granted clemency.

I have not been arrested or been in any kind of trouble since 2012. (That's 12 Years of no arrests) I paid the county, the victim, and the state off in full. I try to help others in the community by volunteering my time and being productive in county events one being Operation backpack. I'm a Third Degree Knight in the Knights of Columbus. I did my time in jail, learned my lesson, and I have paid my debt to society.

I have accomplished one major thing here that I am very proud of the Hernando County Commission now has a plan in place to help former inmates trying to get their lives back the chance to request working off their CRLO balance with community service hours which allows them to get this off back if they are unable to come out of pocket for their balance.

I was not disabled back in 2012 but I am now. I can't work doing any kind of labor due to my physical and mental conditions. I have Stage 3 kidney Failure, PTSD, and I also suffer from bipolar disorder.

I have been found by the Hernando County Courts to be INDIGENT on many occasions am I still am today. I can provide the paperwork to show you I'm indigent and disabled.

I am requesting the Hernando County Board of Commissioners to please Forgive my CRLO Total Balance and to issue me a Satisfaction of Lien today due to disability and medical reasons please.

What date will my case be presented to the board? I want to make sure that I am there if the board has any questions for me?

I just want the Hernando County Board of County Commissioners to know that when I plead nolo contendere on my case on July 17, 2012 and was sentenced to six months in the Hernando County Jail

"I was not informed by the public defender's office that the Judge was going to come after I plead out and was sentenced and sign a civil restitution lien order for cost of incarceration on me on August 22, 2012. If I would have known that the civil lien was going to be put on me, I could have taken this case to trial and won and not had to pay anything for cost of incarceration. The Hernando County Public Defender's office failed me by not informing me of these civil restitution lien orders for cost of incarceration. I did not know that this lien was going to be put on me".

I don't think this is fair of the Public Defender's Office to not inform me of this major lien that would be put on me before I plead out. I was assigned to Ray Shaw he got sick and then came in David Bauer on the day of court. I did not even have any legal counsel until 5 minutes before I was due to see Judge Merritt.

The fact of the matter is I was not informed of the civil restitution lien order for cost of incarceration. If I would have known of this, I would have taken this case to trial and won. This would have impacted the way I would have gone with the outcome of my case. You can look at my court case 2011 CF 1793 and see that I was never made aware of this civil restitution lien until August 22, 2012. I resolved this

case on July 17, 2012.

I am asking that the board please forgive this balance of \$9,000 plus interest and give me the satisfaction of lien paperwork, reduce this balance, and/or let me work it off with community service hours to the board of county commissioners or the Hernando County Government please so I can move on with my life. Just because I am labeled a Felon does not mean that I am a bad person and don't deserve to be informed in my own legal case.
