Pursuant to Section 1.0, General Terms and Conditions, Paragraph 1.24, titled Modification of Contract, this Modification amends the above-referenced Contract awarded to Fire-Dex GW, LLC by Miami-Dade County (the "County").

It is mutually understood and agreed by and between the County and Fire-Dex GW, LLC that this Modification clarifies the Consumer Price Index that was always intended by the parties. Paragraph 2.4, titled Pricing, shall be modified to revise the existing language as follows:

## 2.4 PRICING

The rates offered shall remain fixed for a period of six (6) months after the commencement of the contract. Rates may change semi-annually based on the <u>Consumer Price Index (CPI) – All Urban Consumers, Series ID: CUURS35BSAS, CUUSS35BSAS, Miami-Fort Lauderdale-West Palm Beach, FL, Services, Not Seasonally Adjusted.</u> Awarded Bidder shall submit rate adjustment requests at least 30 days prior to the end of each six-month period.

The period used to calculate the adjustment will include no more than six (6) months, starting from the effective date of the contract, using the index above and include as many months as published (available) in the sixth (6<sup>th</sup>) month, including preliminary [P] numbers during the current six (6) months, as not all months may be available for calculation. If the County authorizes an adjustment, the rate adjustment, if any, will take effect on the first month of the next six (6) month period.

Should the referenced index be discontinued by the BLS, or should its data be unavailable, the County will use the <u>CPI – All Urban Consumers</u>, Series ID: <u>CUURS35BSA0</u>, <u>CUUSS35BSA0</u>, <u>Miami-Fort Lauderdale-West Palm Beach</u>, <u>FL</u>, <u>All Items</u>, <u>Not Seasonally Adjusted</u>.

The County reserves the right to apply any reduction in pricing for each contract year based on the downward change of the CPI.

All terms, covenants and conditions of the original Contract shall remain in full force and effect, except to the extent herein amended.
