NOTICE OF PUBLIC HEARING

Notice is hereby given that the Board of County Commissioners of Hernando County, Florida, will hold a public hearing on Tuesday, August 23, 2022, at 9:00 a.m., or as soon thereafter as possible, in the County Commission Chambers, located in the Hernando County Government Center, 20 North Main Street, Room 160, Brooksville, Florida. The purpose of this hearing is to consider the enactment of an ordinance entitled as follows:

ORDINANCE NO. 2022-_____

AN ORDINANCE OF HERNANDO COUNTY, FLORIDA, CREATING A MUNICIPAL SERVICE BENEFIT UNIT TO BE KNOWN AS THE "HERNANDO COUNTY SEPTIC TO SEWER CONVERSION DISTRICT A MUNICIPAL SERVICE BENEFIT UNIT"; PROVIDING FINDINGS OF FACT; PROVIDING FOR PURPOSE OF THE UNIT; PROVIDING FOR BOUNDARIES OF SAID UNIT; PROVIDING FOR SEWER SYSTEM IMPROVEMENTS AND CONNECTIONS WITHIN SAID UNIT; PROVIDING THAT THE BOARD OF COUNTY COMMISSIONERS OF HERNANDO COUNTY SHALL BE THE GOVERNING BODY OF SAID UNIT; PROVIDING FOR ADMINISTRATION OF SAID UNIT; PROVIDING FOR THE LEVY OF AN EQUITABLE PER LOT/PARCEL ASSESSMENT; PROVIDING FOR LEVY, COLLECTION AND ENFORCEMENT OF THE AFORESAID ASSESSMENT; PROVIDING FOR INCLUSION IN THE HERNANDO COUNTY CODE OF ORDINANCES; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

The Hernando County Septic To Sewer Conversion District A Municipal Service Benefit Unit shall consist of the following described parcels located in unincorporated Hernando County, Florida:

All properties within the unincorporated area of Spring Hill generally located south of Cortez Boulevard, west of Sand Hill Scout Reservation, north of Elgin Boulevard, and west of Commercial Way, as depicted on the map in this Notice. The parcels consist of lots within portions of Spring Hill Unit 22, recorded in Plat Book 10, Page 31, of the Public Records of Hernando County, Florida, generally north of Elgin Boulevard, and Freeport Estates, recorded in Plat Book 21, Page 1, Public Records of Hernando County, Florida.

The proposed improvements and connections within the MSBU shall consist of design, permitting and construction of gravity sewers, including laterals, manholes and gravity pipelines, pressure systems including pumping stations and force mains, and valves and appurtenances to convey wastewater to the Hernando County Glen Water Reclamation Facility, as well as sewer service lines, connections to individual properties, pavement and landscaping restoration.

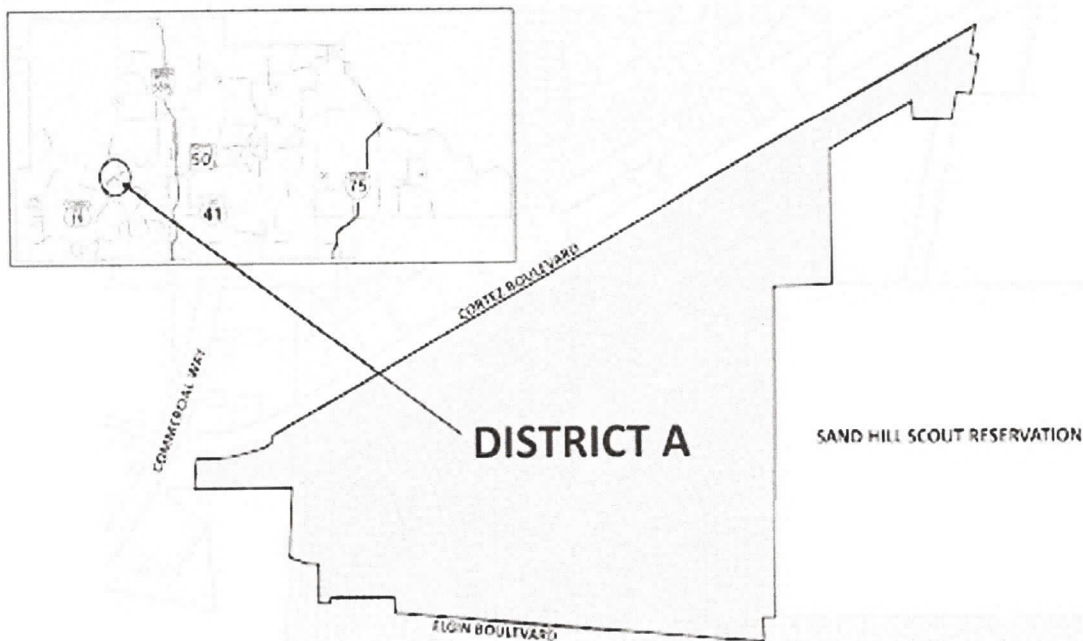
Copies of the proposed ordinance may be inspected by the public during normal business hours at the Hernando County Utilities Department, 15365 Cortez Boulevard, Brooksville, Florida. All interested parties may appear at the meeting or public hearing and be heard with respect to the proposed ordinance.
