CALL TO ORDER

Vice-Chairman Mariano called the meeting to order at 10:01 a.m.

Miscellaneous Business – District One – Commissioner Oakley

- Commissioner Oakley spoke regarding the upcoming Lacochee Community Clean-up to be held on October 15th from 8:00 a.m. to 3:00 p.m.
- He spoke regarding a program for fixing potholes that had been set up by Mr. Branford Adumuah, Interim Assistant County Administrator for Public Infrastructure, and his team.

Discussion was held regarding past discussions and decisions pertaining to funding pothole repairs.

Miscellaneous Business - District Two - Commissioner Moore

- Commissioner Moore extended thoughts and prayers to the communities of Southwest Florida with the aftermath of Hurricane Ian. He spoke regarding how long and difficult the road will be to rebuilding and expressed his appreciation to Staff for all of their efforts.
- He spoke regarding the Ordinance pertaining to political signs noting the part about signs needing to be cleaned up within five calendar days after the election. He noted many people had reached out to him about the signs and requested an update from Staff.

Ms. Sally Sherman, Assistant County Administrator for Development Services, explained they had contacted the candidates regarding the signs, that they had already removed many of them, and that they were getting ready to send out citations.

Discussion was held regarding the fines associated with the citations.

Miscellaneous Business - District Three - Commissioner Starkey

- Chairman Starkey expressed her appreciation to Staff for their efforts during the community clean-up in the Holiday Area. She noted they had collected six tons of trash out of the area.
- She mentioned that at her last FAC Conference they had a conversation regarding septic to sewer conversion.

Miscellaneous Business - District Four - Commissioner Fitzpatrick

- Commissioner Fitzpatrick distributed a list of roads that were reviewed by a Fire Rescue Inspector in October 2021 while photographs were displayed. She spoke regarding the conditions of the road, concerns raised by the Inspector, roads that had previously had one-time fixes, the costs involved with a one-time fix for the other roads, debris that was placed in the road by the community in attempts to fix them and the additional costs that would be incurred to remove it, and Wonder Avenue which was a road that flooded and had dead fish on it. She requested a one-time fix of Wonder Avenue in the amount of \$6,500.00.

Discussion was held regarding whether the roads were public or private; that Staff will need to dive into the community to come up with a plan for the roads; and that it would cost over \$45 million to completely pave all of the roads.

Approved a one-time fix in the amount of \$6,500.00 for Wonder Avenue.

Commissioner Fitzpatrick led discussion regarding the PVAS program and different alternatives; impassable roads; other roads that needed only the trees and clearance maintained; and that the debris would need to be cleared by the community. She requested right-of-way maintenance, road stabilizing, and regrading of Helena Street in the amount of \$10,500.00.
