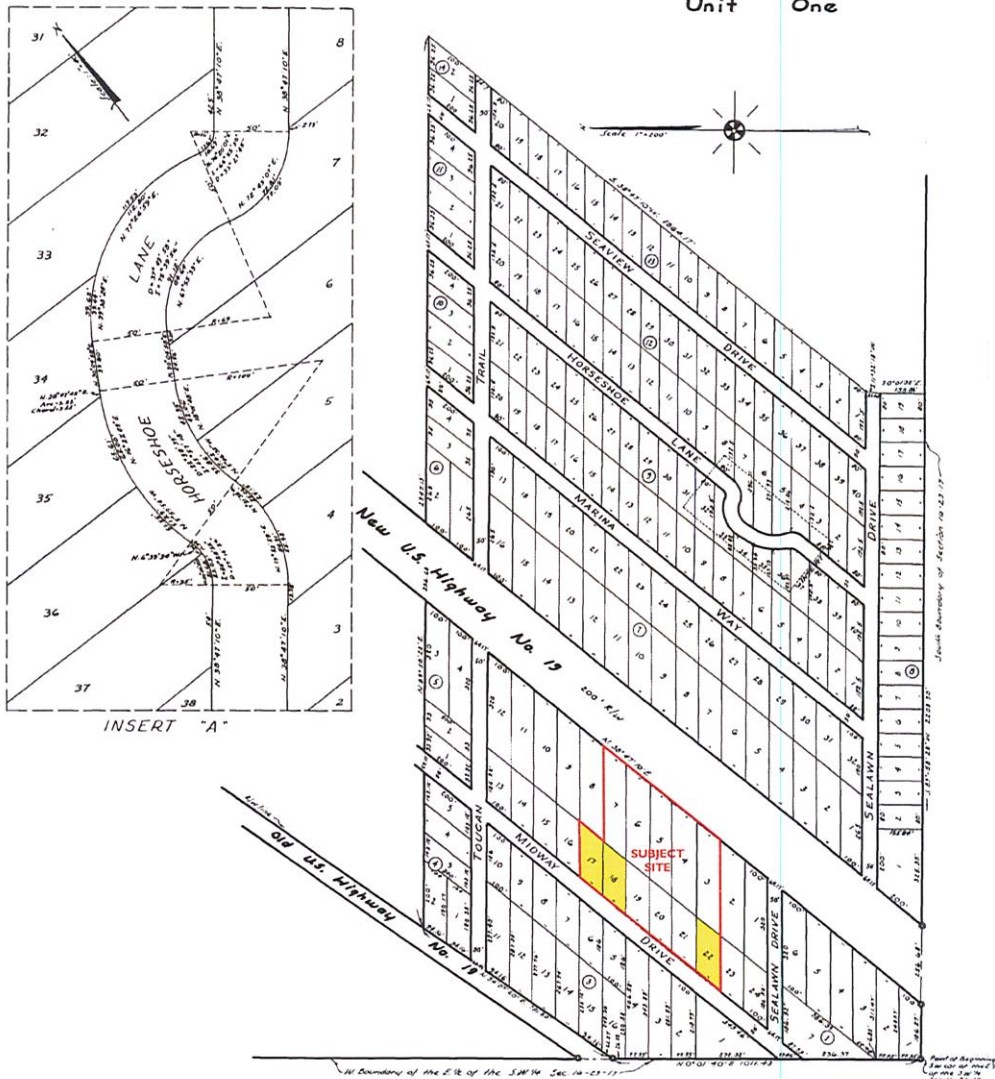

## Description

A tract of land being a part of Section 16, Township 23 South, Range 17 East, Hernando County, Florida and being more particularly described as follows: For a Point of Beginning, begin at the Southwest corner of the East 1/2 of the Southwest 1/4 of said Section 16; Thence with the East Boundary of the East 1/2 of the Southwest 1/4 of said Section 16, North 0°10'40" East 101.43 feet to the East right-of-way line of old U.S. Highway No. 13; Thence with said East right-of-way line, North 34°07'20" East 281.80 feet, Thence North 41°38'28" East 294.13 feet, Thence South 38°17'10" West 166.11 feet, Thence South 41°38'28" West 310.10 feet, Thence South 0°10'40" East 101.43 feet to the South Boundary of said Section 16; Thence with said South Boundary of Section 16, South 85°58'28" West 220.30 feet to the Point of Beginning less and except a 100' right-of-way for New U.S. Highway No. 13 said right-of-way being more particularly described as follows: Commence of the Southwest corner of the East 1/2 of the Southwest 1/4 of said Section 16; Thence with the South Boundary of said Section 16, North 85°58'28" East 166.11 feet to the East right-of-way line of New U.S. Highway No. 13 and the Point of Beginning; Thence with said right-of-way line, North 34°07'20" East 281.80 feet, Thence North 41°38'28" East 294.13 feet to the East right-of-way line of New U.S. Highway No. 13; Thence with said East right-of-way line, South 41°38'28" West 310.10 feet to the South Boundary of said Section 16; Thence with said South Boundary of Section 16, South 85°58'28" West 220.30 feet to the Point of Beginning.
