AN ORDINANCE AMENDING APPENDIX A, ARTICLE V, SECTION 2 OF THE HERNANDO COUNTY CODE, RELATING TO ZONING PERMIT AND CERTIFICATE OF USE; AMENDING SIZE REQUIREMENTS FOR STRUCTURES WITH IMPERVIOUS ROOF COVERINGS THAT REQUIRE A ZONING PERMIT PRIOR TO CONSTRUCTION OR PERMIT; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR THE REPEAL OF CONFLICTING PROVISIONS; AND PROVIDING FOR AN EFFECTIVE DATE.
