ORDINANCE NO. 2024-05

AN ORDINANCE REPEALING DIVISION 186, ARTICLE III OF CHAPTER 24 OF THE HERNANDO COUNTY CODE, WARBLER ROAD PAVING MUNICIPAL SERVICE BENEFIT UNIT; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR THE REPEAL OF CONFLICTING PROVISIONS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on March 8, 2022, the Board of County Commissioners enacted Ordinance 2022-08, codified as Division 186, Article III of Hernando County Code Ch. 24, creating the “Warbler Road Paving Municipal Service Benefit Unit”; and

WHEREAS, on February 27, 2024, the Board of County Commissioners determined that the above-referenced ordinance should be repealed.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF HERNANDO COUNTY, FLORIDA, AS FOLLOWS:

SECTION I. Repeal of Warbler Road Paving Municipal Service Benefit Unit.

Hernando County Code §§ 24-2035 through 24-2039, inclusive, are hereby repealed.

SECTION II. Severability.

It is declared to be the intent of the Board of County Commissioners of Hernando County, Florida, that if any section, subsection, clause, sentence, phrase, or provision of this Ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the validity of the remaining portions of this Ordinance.

SECTION III. Inclusion in the Code.

It is the intention of the Board of County Commissioners, and it is hereby provided, that the provisions of this ordinance shall become and be made a part of the Code of Ordinances of

Hernando County, Florida. To this end, the section of this ordinance may be renumbered or re-lettered to accomplish such intention, and that the word "ordinance" may be changed to "section," "article," or to another appropriate designation.

SECTION IV. Conflicting Provisions Repealed.

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION V. Effective Date.

A certified copy of this Ordinance shall be filed in the Office of the Secretary of State by the Clerk of the Board within ten (10) days after adoption of this Ordinance.
