My passion is and has been our natural resources and our waterways, here in Hernando County.

The following are just a few matters I have been involved in:

- -One of the early advocates involved with lobbing, than Sen. Wilton Simpson to a Weeki Wachee River Rescue team general meeting in 2016 with our concerns of the need for a Capacity Study
- -Worked with a number of agencies, such as but not limited to SWFWMD, FWC, County and State on the Springs Protection Zone for Weeki Wachee River.
- -Part of the Hernando Co Adopted -a-Waterway Program maintaining regular cleanups of Weeki Wachee River which our Organization Weeki Wachee River Rescue Team has adopted, and also Rogers Park with Parks & Recs
- -Was instrumental in plotting the 1/2mile markers and evacuation locations on our Waterway, with Hernando County Fire Rescue and County staff. Than getting these maps laminated, for distribution to all our local vendors.
- -Constructed wooded street number signs for residential homes on our main waterway, to assist HSCO Marine Deputies with location bearings, while on patrol.
- -Past President of the Weeki Wachee Crime/Marine Watch with HCSO which, we use to and still use our own vessels to monitor and report waterway activity.
- -Worked with SWFWMD, to get an authorization letter for HCSO to trespass on district lands, so we did not have to have, No Trespassing Signs ever 100' on Waterway to enforce in May 2021.
- -placement of new County SPZ "In the Zone signs" on main body of Waterway
