NASHVILLE, Tenn., — CoreTrust, a leading Group Purchasing Organization (GPO), today announced cooperative agreements with major municipalities, including the Cities of Houston and Los Angeles, to launch its public sector cooperative. The initiative—unveiled at the NIGP (The Institute for Public Procurement) Annual Forum 2025—extends CoreTrust's proven savings model to government agencies nationwide, unlocking value in a \$490 billion market underserved by traditional cooperatives.

With over a decade delivering measurable savings to Fortune 1000 companies through its \$8 billion in annual purchasing power, CoreTrust is now addressing the chronic procurement inefficiencies plaguing government entities. Through lead-agency contracting, the cooperative enables government entities to access competitively bid, pre-negotiated contracts while maintaining full compliance with local procurement regulations. CoreTrust launches with awarded suppliers including Healthee for employee healthcare navigation and Pavement Management Group for infrastructure services, plus a robust pipeline across technology, office supplies, furniture, and language accessibility services.

"Procurement organizations are always navigating competing demands and pressures——from compliance to limited staffing and funding, to meeting the demands of our agency departments and customers," said Jedediah Greenfield, Chief Procurement Officer of the City of Houston. "Being a lead agency for CoreTrust allows us to address each of these issues, all while taking a more proactive leadership role in making governments across the country more efficient and effective."

The timing of CoreTrust's public sector launch addresses critical market pressures. Post pandemic budget constraints and administration changes have intensified pressure on agencies to maximize taxpayer value. Meanwhile, <u>data shows</u> that consolidated procurement efforts have generated ~\$667 billion in savings, with tens of billions more on the table by eliminating fragmented, duplicative contracting processes. - Robert Zingelmann, former CFO of Region 4 Education Service Center (ESC), rounds out
 the team with his extensive background in educational service center operations and
 cooperative purchasing financial management.

"Public sector organizations are under immense pressure to do more with less—while navigating complex compliance and procurement requirements," said James Hallock, Interim CEO at CoreTrust. "This expansion marks a strategic evolution for us. We've assembled a powerhouse team with deep experience from the nation's largest government agencies to develop a solution tailored for the public arena."
