Notice is hereby given, pursuant to Section 14-64.14 of the Hernando County Code of Ordinances, that the Board of County Commissioners of Hernando County, Florida, will conduct a public hearing to consider the adoption of a resolution incorporating a schedule of revised tipping fees to be charged by the County for receiving and disposing of solid waste and special waste within the County.

The public hearing will be held on **Tuesday, June 9, 2026 at 9:00 a.m.**, or as soon thereafter as possible, in the County Commission Chambers, located in the Hernando County Government Center, 20 North Main Street, Room 160, Brooksville, Florida, for the purpose of receiving public comment on the proposed fees. All interested persons may appear at the meeting or public hearing and be heard with respect to the proposed resolution.

If a person decides to appeal any decision made by the Board of County Commissioners with respect to any matter considered at the hearing, such person will need a record of the proceedings and may need to ensure that a verbatim record is made, including the testimony and evidence upon which the appeal is to be made.

Public participation is solicited without regard to race, color, national origin, age, sex, religion, disability, or family status.
