RESOLUTION 2023 – 38

WHEREAS, the **KIWANIS CLUB OF BROOKSVILLE** was chartered on March 22, 1923; and

WHEREAS, the **KIWANIS CLUB OF BROOKSVILLE** began its support of area youth by sponsoring Boy Scout Troop 71; and

WHEREAS, during the 1940's the **KIWANIS CLUB OF BROOKSVILLE** members were very involved locally in supporting the war effort; and

WHEREAS, a **KIWANIS CLUB OF BROOKSVILLE** tradition, Kiwanis Kids Day, began in 1955; and

WHEREAS, in 1974 the **KIWANIS CLUB OF BROOKSVILLE** presented the first Brooksville Christmas Parade, a tradition that has continued now for nearly 50 years with the support of the City of Brooksville; and

WHEREAS, in the 1980's the **KIWANIS CLUB OF BROOKSVILLE** began sponsoring the Kiwanis Invitational Wrestling Tournament; and

WHEREAS, in the 1990's the **KIWANIS CLUB OF BROOKSVILLE** formed the Brooksville Kiwanis Foundation to fund and support scholarships for local high school students who are furthering their education; and

WHEREAS, **KIWANIS CLUB OF BROOKSVILLE** has provided leaders for the Florida District of Kiwanis International with two Florida District Governors and fourteen Division Eight Lieutenant Governors; and

WHEREAS, the **KIWANIS CLUB OF BROOKSVILLE** will continue to strive to improve this community one child at a time.

NOW, THEREFORE, BE IT RESOLVED BY THE HERNANDO COUNTY BOARD OF COUNTY COMMISSIONERS AS FOLLOWS:


