## F. Narrative Description

Applicant is seeking approximately 17.3(±) acres from PDP-CP (Planned Development Project - Corporate Park) to PDP-IND (Planned Development – Industrial). The subject property is located west of Broad Street and north of Ayres Road in Hernando County, FL. Specifically, the parcel key is 1599595. The request is to rezone this subject site to allow for a maximum of 100,000sqft of storage space with buildings to be placed behind industrial uses fronting Ayers Rd. Building height is not to exceed 20ft. A vegetative buffer of at least five (5) feet in width shall abut the street right-of-way/pavements for at least half of the street right-of-way frontage. The site is currently vacant with no wetlands on site nor is site located in a flood zone. The parcel to the southeast, which appears to be a retention pond, is owned by the Florida Department of Transportation.
