# RESOLUTION NO. 2023 - 244

**WHEREAS,** Hernando County ("County") has established development requirements that must be met as conditions for development review and approval; and

WHEREAS, the County incurs costs in the administration and processing of these requirements; and

WHEREAS, Planning & Zoning fees have not been updated since 2016; and

**WHEREAS,** it is the desire and intent of the Board of County Commissioners to offset these costs of administration by adopting an updated fee schedule, pursuant to Appendix A. Article V, Section 7, Hernando County Code of Ordinances.

## NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF HERNANDO COUNTY, FLORIDA, AS FOLLOWS:

**SECTION 1.** The fee schedules for development activity by the Planning & Zoning Services Divisions as attached hereto as Exhibits A and B are hereby approved and adopted.

**SECTION 2.** Resolution No. 2016-40 is hereby superseded and shall have no further force and effect.

**SECTION 3.** The Chairperson of the Board of County Commissioners is hereby authorized to execute and sign this Resolution on behalf of the Board of County Commissioners.

**SECTION 4.** This Resolution shall take effect upon adoption. Staff is hereby authorized to immediately implement the fee schedule attached hereto for development activity.
