The Board authorizes Vice-Chairman Hawkins to execute documents on the Board's behalf in the event that Chairwoman Narverud is absent. 17 18 Section 2. Documents signed by Vice-Chairman Hawkins shall be as legally cognizable and binding on the Board as those that are signed by Chairwoman Narverud in the normal course of 19 20 business.
