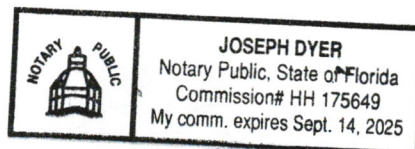

Good afternoon,

This is in reference to Parcel Key 00423107. 14080 Sorrel Street, Brooksville FL 34614

We have enclosed an application to amend our existing Special Exception Use Permit to allow us to store up to 60 dumpsters, as opposed to 12 dumpsters. We do not anticipate having all 60 dumpsters on the premises at one time, but there are rare occasions where it may happen, so we wanted to be sure that it will be allowed.

In order to accommodate the additional storage, we have dedicated a separate area on our property that is about 65' wide x 122' deep. (drawing has been provided for reference)

We understand that the same rule applies where we need to block the dumpsters from view of the road as well as the adjacent properties. We lost a large portion of our fence from an earlier storm and would like to use privacy screen as a more cost effective solution if possible. It is sturdy, provides great coverage, and is a lot easier to install/maintain than a solid fence is. If you feel this is not going to be opaque enough, we can always double up the fabric for each section. (Patiobay 6 x 50 FT Privacy Screen Fence, 170GSM 90% blockage Mesh Shade Net) Here is a link from Amazon showing the cost and details:
