#### TITLE

Purchase of Various Vehicles and Equipment Through Fleet Replacement Program

#### **BRIEF OVERVIEW**

Hernando County Fleet Management is requesting the ability purchase a total of fifty-six (56) vehicles/equipment for the County. Thirty (30) are new additions to the Vehicle Replacement Program and twenty-six (26) are actual replacements. All twenty-six (26) of the vehicles/equipment being turned in by the departments will go to surplus. The estimated cost to purchase the vehicles/equipment is \$14,937,551.28. Eleven (11) of the vehicles/equipment will be purchased by departments utilizing the one-time payment option estimated at \$2,020,606.50 and seven (7) of the vehicles will be purchased by grant funds estimated at \$2,486,991.00. The remaining thirty-eight (38) will be part of the Fleet Replacement Program with an estimated cost of \$10,429,953.78. Funds will be available with the approval of the future requested loan. Departments have budgeted for these vehicles in their FY 25 budgets.

## FINANCIAL IMPACT

Funding for vehicles and equipment will be available in the Fleet Replacement Program **Fund: 5081** - Fleet Replacement Program, **Department: 08031** - Fleet Replacement Program, **Account: 5606405** - Equip-Vehicle, trailer > \$500, with the approval of the attached replacement list.

## RECOMMENDATION
