License Agreements With American Towers, LLC, and GTP Acquisition Partners II, LLC, for Various Tower Sites Required to Facilitate Implementation of P-25 Interoperable Public Safety Radio Network System

BRIEF OVERVIEW

On June 22, 2021, the Board awarded Communications International, Inc., with the P-25 Interoperable Public Safety Radio Network System (MT 18352). As part of that agreement there were to be eight (8) cell tower sites to facilitate the use of the new equipment. American Tower, LLC is to provide services relating to three (3) of those towers. The towers are located at the following locations:

1. 23305 Powell Road, Brooksville, FL 34601
2. 7052 Treiman Boulevard, Webster, FL 33597
3. 5308 Drew Street, Brooksville, FL 34604

The Initial Term is a period of fourteen (14) years beginning on the Commencement Date. The "Commencement Date" shall be the earlier of: (i) the date of Licensor's issuance of a NTP or (ii) December 1, 2021. Monthly license fee payments of various amounts shown below will begin the month following the date of commencement and will increase 3% each year. There are three (3) renewal periods of five (5) years each.

FINANCIAL IMPACT

The operational costs will be paid out of the HCSO 800 MHz fund. The initial costs will be paid from the funding set aside by the Board for the Radio System.
