### BRIEF OVERVIEW

On October 18, 2022, Hernando County Department of Public Works requested piggyback of Polk County Contract 22-245 Pavement Preservation and Recycling Treatments, with a contract expiration date of April 30, 2025, with automatic renewal of two (2) additional one (1) year periods.

Hernando County Department of Public Works currently has no Pavement Preservation and Recycling Treatments Contract and requests piggyback approval with Asphalt Paving Systems to provide those Contract services, in the annual estimated amount of \$2,000,000.00.

Hernando County Procurement Department issued Contract No. 23-P0008/DK for tracking purposes.

The Chief Procurement Officer has reviewed this requirement for conformance to Procurement Ordinance and Purchasing Policies and Procedures.
