After solicitation of the bid document, 4 responses and 2 bids were received for the Fort Dade Ave (Cobb to US98) Resurfacing SCOP project.

The solicitation was print advertised in two newspapers on April 12 and April 14 and posted to OpenGov, Hernando County's Procurement website on April 12, 2023. 2,375 OpenGov users were notified of the solicitation. Of those 2,375 vendors, 736 were classified business owners. 2 of the 4 responses were no bids. Reasons provided were "too busy" and "do not provide requested services".
