Good afternoon Gentlemen,

This is an FYI- We recently processed a large cleanup on one of Mrs. Nordgren's properties in which a tenant was allowing tree debris to be dumped throughout the property.

Brief synopsis of the case facts:

1. On July 9, 2019, Case # 401030 was initiated by complaints to Code Enforcement regarding excessive tree debris dumping at 5142 Drew Street. These complaints came from multiple neighboring properties.
2. On July 25, 2019 an inspection of the subject property showed large piles of cut tree debris throughout the property. Photos were documented.
3. On August 5, 2019, The property owner was notified of the violations and we obtained receipt of service from that notification.
4. On September 11, 2019, the property was physically posted with a green card indicating that abatement of the violation will be scheduled after 10 days of the posting.
5. On October 2, 2019, the property was cleaned by the County Contractor. Over 70 tons of tree debris was weighed and disposed of at the County Landfill. The billing for this clean-up came to **\$23,715.40**.
6. On October 10, 2019 the property was re-inspection and determined to be in compliance. Photos were documented.

We are currently processing payment to the contractor and subsequently filing for lien. I've attached the initial report, notices, and violation photos in the first attachment. The second attachment is the remedy photos and billing documents. I reviewed the documents on this file and all procedures for property maintenance appear to be followed prior to clean-up actions.
