

STRATEGY 1.11B(1)

Review of developments and comprehensive plan amendments shall evaluate whether proposals have the following characteristics of urban sprawl development:

- A. Substantial areas of low-intensity, low-density or single-use development
- D. Inadequate protection and conservation of natural resources, wetlands, waterbodies, floodplains, native vegetation, environmentally sensitive areas, or natural groundwater aquifer recharge areas
- K. poor accessibility among linked or related land uses

Top Florida officials OK buying 340 acres from **luxury** golf developer

In a statement, Agriculture Commissioner Wilton Simpson praises the course reversal.

Gov. Ron DeSantis, Attorney General James Uthmeier and Agriculture Commissioner Wilton Simpson voted Tuesday morning to greenlight the purchase of 340 acres of forest land in Hernando County for conservation.

The seller: a luxury golf resort called Cabot Citrus that a year ago had received initial state approval to shrink that same forest by getting more than 300 acres of preserved public land to add to its property. Unlike that previous proposal, though, Tuesday's vote is a straightforward purchase and not a trade - meaning the state will add to its conservation land without swapping away any acres in return.

After the Tampa Bay Times revealed that proposed land swap in August, it escalated already explosive public outrage about the DeSantis administration's plans for public lands, including the proposed development of golf courses and hotels on state parks.

Cabot Citrus quietly withdrew its proposal, the Times previously reported.

The governor initially defended the land swap last year when asked about it by a Times reporter. But on Tuesday, the governor's office put out a news release celebrating all of the land acquisitions the Cabinet voted to approve, including the Cabot parcel.

Adding to the intrigue before Tuesday's vote, the governor was photographed May 18 wearing a hat with what appeared to be Cabot Citrus' logo during a round of golf with the head of Florida's wildlife agency, Rodney Parreto. Barreto then posted the image to Facebook.

The land the state is now slated to purchase is fust southeast of Calot Cifrus' existing operation, with multiple 18-hele courses and a suite of cottages for purchase starting at nearly \$1.7 million.

The property borders the Withlacoochee State Forest, the same habitat that the Cabinet last year granted early approval to trade away to the golf company. In exchange, Cabot had pledged to give the state 861 acres of Cedar Key timberland of unclear conservation value.

After Tuesday's vote. the Florida Department of Environmental Protection is now tasked with carrying out the possible purchase.

It's still not clear how much state money would be used to buy the land. The proposal doesn't list how much the land is worth, and it still needs to be appraised.

The Upland LLC, which was formed earlier this year, withdrew its proposal May 19 amid surging bipartisan opposition, including from President Donald Trump's chief of staff, Susie Wiles.
