#### **BRIEF OVERVIEW**

On September 26, 2023, the Board approved Contract No. 23-T00040/AP Pre-qualification for Construction Services under \$500,000, pre-qualifying firms under three categories, A-Public Works, C-Utilities, and D-Facilities, to provide quotes for County projects as needed.

On January 11, 2024, the Utilities Department issued a Request for Quotes (23-T00040/AP Quote #3) for Burger King Lift Station Rehab.

The Request for Quote was sent to two pre-qualified firms for Category C-Utilities.

- Deeb Construction & Development Co
- Goodwin Brothers Construction, Inc.

One (1) reply to the Request for Quote was received by the Quote Due Date of January 21, 2024, from the following firm:
