**MOWING SERVICES – HERNANDO BEACH**

The following changes, additions and/or deletions are hereby made a part of the Contract Documents for the **CONTRACT No. 22-T00043/TB** as fully and completely as if the same were fully set forth therein:

1. Added to Section V: SCOPE AND SPECIFICATIONS, 70. Technical Specifications, 70.2 Areas of Work: 70.2.5. THROUGH 70.2.11.

**70.2. AREAS OF WORK:** All County roadways as highlighted on Exhibit A, which are within the Hernando Beach subdivision excluding South Hernando Beach and includes all roadway sections found at the end of each canal. South Hernando Beach includes the housing area entered by way of Jewfish Drive or Bluefish Drive.

- 70.2.1.** Includes both sides of the roadways of County Right of Ways within the areas outlined in Exhibit A.
- 70.2.2.** Includes ALL canal endings within the areas outlined in Exhibit A. These average about one hundred (100) feet in length each.
- 70.2.3.** Includes both sides of Shoal Line Boulevard, from Cortez Avenue to Osowaw Boulevard.
- 70.2.4.** Includes the landscaped median located at the intersection of Shoal Line Boulevard and Osowaw Boulevard.
- 70.2.5.** Includes both sides of Tarpon Blvd - From Osowaw Blvd to US 19.
- 70.2.6.** Includes both sides of Osowaw Blvd - Pasco Co. Line to US 19.
- 70.2.7.** Includes both sides of Indian Bay Rd - From Osowaw to Left turn.
- 70.2.8.** Includes both sides of Gulf Dr. - From Jills Ln to E Dead End.
- 70.2.9.** Includes both sides of Cortez Blvd - From Bayport Entrance to US.
- 70.2.10.** Includes both sides of Bayou Dr - From Cortez Blvd to Pine Island Dr.
- 70.2.11.** Includes both sides of Pine Island Dr - From Cortez Blvd to Park Entrance.
