

This letter is being tendered in order to request permitting for fifty-two (52) miscellaneous events at varying times throughout the year. These events will list as follows:

- 1. Six (6) music concerts
- 2. Wedding events
- 3. Community Outreach Events

The actual dates for the concerts and events is unknown due to artist/entertainer availability; however, all of the concerts will be held on a Friday or <u>Saturday evening</u> with a start of no earlier than <u>3pm</u>. To date, Whitehead Farms has hosted two music concerts, with one of them being a Community Outreach which was tailored to First Responders. The event hosted Hernando County Fire Rescue, Hernando County Sheriff's Office, Med Tran Air Ambulance, numerous Tampa Bay area agencies (both LE and Fire Rescue), and retired law enforcement and fire fighters. Many Hernando County residents attended the event and helped show their support for their local heroes.

At each event that Whitehead Farms has hosted, we have utilized the Sheriff's Office "Off-Duty Detail" program which allows Deputies to provide security and traffic assistance before, during, and after the event. For the first event, six (6) Deputies were hired to provide security and traffic assistance. For the second event, Whitehead Farms anticipated more guests, and eight (8) Deputies were hired to provide this service. Along with the law enforcement presence, two off-duty Hernando County Fire Rescue EMS personnel were hired to provide medical assistance should an occasion arise that required immediate medical attention.

Before both events, two (2) Deputies were stationed at Cortez Blvd and Cedar Lane to coordinate and direct traffic into the event. Two Deputies were stationed directly on Cedar Lane at the entrance to Whitehead Farms to ensure a smooth traffic flow and prevent congestion on Cedar Lane. After the concerts, the Deputies assisted with the outflow of traffic at the same stations and no issues were noted. The Deputies who were providing security were on foot throughout the event and no issues were reported by the Deputies or guest for both events. There were no medical episodes that were reported, but the EMS personnel were in a clearly and distinctly marked tent with medical apparatus available for anything from heat exhaustion to trauma. Needless to say, Whitehead Farms has provided guests ample security for the events we've hosted thus far.

Both events were also an avenue for many local small business owners and vendors to showcase their products and delicacies. For the first event, four local food vendors were on hand to provide food and concessions to guests. Six local food vendors provided food and concessions for the second event. The events also provided Whitehead Farms an opportunity to give several thousand dollars to the Hernando High School (HHS) Chapter of the Future Farmers of America (FFA). The HHS FFA were in the parking area and directed concert goers to designated parking areas which streamlined the parking system.

It is our sincere request that the Honorable Members of the Hernando County Commission approve Whitehead Farms for the aforementioned fifty-two (52) events. Whitehead Farms is taking great care to provide citizens of Hernando County with a safe, enjoyable, and affordable venue that also brings guests from surrounding counties to our wonderful and growing county. With your approval, Whitehead Farms can continue to showcase Hernando County and our local small business vendors.
