Award of Contract to HDR Engineering, Inc., for Engineering Services for Landfill Cell No. 4 Expansion Project (RFQ No. 18-R00129/PH; Amount: \$920,711.77)

BRIEF OVERVIEW

On October 9, 2018, The Board of County Commissioners (BOCC) authorized the Purchasing and Contracts Department to begin negotiations with HDR Engineering, Inc., as the top-ranked firm for Engineering Services for the Landfill Cell 4 Expansion project (Doc ID 14893). The resulting Contract and proposed fee schedule are attached for your review.

The project will be implemented in three (3) phases:

- Phase 1 - Site Master Planning Update and Conceptual Design
- Phase 2 - Detailed Design and Permitting
- Phase 3 - Construction Phase Services

Because the specific improvements to be designed are constructed and have not been fully defined, only Phase 1 work is being identified at this time. A more detailed Scope of Services, budgets and schedules for Phases 2 and 3 will be developed after Phase 1 work has been completed and will be presented to the Board at future meetings.

FINANCIAL IMPACT

Funding is available in account 4461-07681-5303103 (Professional Services - Engineering) in the amount of \$1,600,000.00.

LEGAL NOTE

The Board has the authority to take the recommended action pursuant to Part II, Chapter 2, Article V of the Hernando County Code of Ordinances.

RECOMMENDATION

It is recommended that the Board approve the Contract Award of RFQ No. 18-R00129/PH to HDR Engineering, Inc., of Tampa, Florida, in the amount of \$920,711.77 for Phase 1. The term of the resulting Contract is for forty-eight (48) months or through construction completion, whichever is greater.
