AMENDMENT NO. 1 TO AGREEMENT NO. LPA0109 BETWEEN

FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION AND HERNANDO COUNTY

This Amendment to Agreement No. LPA0109 (Agreement) is made by and between the Department of Environmental Protection (Department), an agency of the State of Florida, and Hernando County (Grantee), on the date last signed below.

WHEREAS, the Department entered into the Agreement with the Grantee for Hernando County Glen Water Reclamation Facility (WRF) Denitrification Upgrades (Project), effective April 21, 2021; and,

WHEREAS, the Grantee has requested an extension of the Agreement due to construction delays; and,

WHEREAS, other changes to the Agreement are necessary; and,

WHEREAS, the parties have agreed to amend the Agreement as set forth herein.

NOW THEREFORE, the parties agree as follows:

- 1. Section 3. of the Standard Grant Agreement is hereby revised to change the Date of Expiration to September 30, 2027. The Department and the Grantee shall continue to perform their respective duties during this extension period pursuant to the same terms and conditions provided in the Agreement.
- 2. Section 6. of the Standard Grant Agreement is hereby revised to the following:

All references in the Agreement to Attachment 3 shall hereinafter refer to Attachment 3-1, Revised Grant Work Plan.
- 5. Attachment 5, Special Audit Requirements, is hereby deleted in its entirety and replaced with Attachment 5-1, Revised Special Audit Requirements, as attached to this Amendment and hereby incorporated into the Agreement. All references in the Agreement to Attachment 5 shall hereinafter refer to Attachment 5-1, Revised Special Audit Requirements.
- 6. Exhibit A, Progress Report Form, is hereby deleted in its entirety and replaced with Exhibit A-1, attached hereto and made a part of the Agreement. All references in the Agreement to Exhibit A shall hereinafter refer to Exhibit A-1.
- 7. All other terms and conditions of the Agreement remain in effect. If and to the extent that any inconsistency may appear between the Agreement and this Amendment, the provisions of this Amendment shall control.

ATTACHMENT 3-1 REVISED GRANT WORK PLAN

PROJECT TITLE: Hernando County Glen Water Reclamation Facility (WRF) Denitrification Upgrades

PROJECT LOCATION: The Project will be located in the City of Weeki Wachee within Hernando County; Lat/Long (28.5823, -82.5359). See Figure 1 for a site plan.

PROJECT BACKGROUND: The Florida Department of Environmental Protection completed a BMAP study and determined that the Weeki Wachee Spring, an Outstanding Florida Spring, is impaired by excessive nitrogen. To mitigate the impairment, a total maximum daily load (TDML) for total nitrogen has been established for the spring. Hernando County, FL (Grantee) identified wastewater treatment improvements at the Hernando County Glen Water Reclamation Facility (WRF) as a solution for reducing nitrogen groundwater contamination to the Weeki Wachee Spring.

PROJECT DESCRIPTION: The Grantee will install wastewater treatment improvements at the Hernando County Glen WRF necessary to achieve the advanced wastewater treatment (AWT) standard of 3 mg/L total nitrogen. The Grantee will hire an engineering design consultant to design and perform contract administrative services for the construction of anoxic denitrification concrete tankage to reduce the nitrogen discharge at the WRF.

The DEP Grant Funds associated with this Agreement were awarded based on local contributions pledged towards the total project costs: \$1,300,000 from Hernando County. A summary of the local contributions will be required in the Final Quarterly Progress Report, and financial supporting documentation shall be provided upon request.

TASKS: All documentation should be submitted electronically unless otherwise indicated and should be submitted prior to the expiration of the grant agreement.

Task 1: Design and Permitting

Deliverables: The Grantee will complete the design of wastewater treatment improvements and obtain all necessary permits for construction of the project.

Documentation: The Grantee will submit: 1) a signed acceptance of the completed work to date, as provided in the Grantee's Certification of Payment Request; and 2) a summary of design activities to date, indicating the percentage of design completion for the time period covered in the payment request. For the final documentation, the Grantee will also submit a copy of the design completed with the funding provided for this task and a list of all required permits identifying issue dates and issuing authorities.

Performance Standard: The Department's Grant Manager will review the documentation to verify that the deliverables have been completed as described above. Upon review and written acceptance by the Department's Grant Manager, the Grantee may proceed with payment request submittal.

Payment Request Schedule: The Grantee may submit a payment request for cost reimbursement no more frequently than monthly.

Task 2: Construction

Deliverables: The Grantee will construct wastewater treatment improvements in accordance with the final design.

Documentation: The Grantee will submit: 1) a signed summary of activities completed for the period of work covered in the payment request, using the format provided by the Department's Grant Manager. Upon request by the Department's Grant Manager, the Grantee will provide additional supporting documentation relating to this task.

Performance Standard: The Department's Grant Manager will review the documentation to verify that the deliverables have been completed as described above. Upon review and written acceptance by the Department's Grant Manager, a payment request may be processed.

Payment Request Schedule: The Grantee may submit a payment request for cost reimbursement no more frequently than monthly.

PROJECT TIMELINE & BUDGET DETAIL: The tasks must be completed by the corresponding task end date. Cost reimbursable grant funding must not exceed the budget amounts as indicated below.

Note that, per Section 8 of Attachment 1 in the Agreement, authorization for continuation and completion of work and any associated payments may be rescinded, with proper notice, at the discretion of the Department if the Legislature reduces or eliminates appropriations. Extending the contract end date carries the risk that funds for this project may become unavailable in the future. This should be a consideration for the Grantee with this and future requests for extension.

AUDITS

PART I: FEDERALLY FUNDED

This part is applicable if the recipient is a State or local government or a non-profit organization as defined in 2 CFR §200.330

- 1. A recipient that expends \$1,000,000 or more in Federal awards in its fiscal year, must have a single or program-specific audit conducted in accordance with the provisions of 2 CFR Part 200, Subpart F.
