## PRESENTATIONS

Presentation by the Florida Department of Transportation on the Strategic Intermodal System (SIS) 2050 Multi-Modal Unfunded Needs Plan

Mr. Esposito reviewed the agenda item and staff recommendation, followed by the Board's review of a recorded presentation from Lori Kent, SIS Coordinator for the Florida Department of Transportation District 7, regarding the SIS 2050 Multi-Modal Unfunded Needs Plan. Chair Bays inquired as to how funding was impacted by the government shutdown. Ms. Ziegler clarified that federal monies are affected, but this initiative is funded with state dollars and should not be impacted.

She further noted that data from the Hernando-Citrus Long-Range Transportation Plan (LRTP) was used in developing the first draft of the SIS plan. Ms. Kent will present the draft plan at a future MPO Board meeting, likely in January or February 2026.

Presentation by the Florida Department of Transportation on the Tentative Five-Year Work Program (FY 2027-FY 2031)

Suzanne Ziegler, Government Liaison Manager for the Florida Department of Transportation District 7, delivered a presentation outlining programming strategies and the proposed FDOT Tentative Five-Year Work Program for FY 2027-FY 2031. A flyer detailing the public hearing process, provided by FDOT, was included in the meeting packets and is also available on the MPO's website. Ms. Ziegler also shared the public comment webpage, which was open from October 20 through November 3, 2025, and noted that she would be happy to relay any comments from the Board.

She explained that resurfacing projects are illustrated on a map within the presentation, with a detailed list included in the meeting packets. In addition, Ms. Ziegler addressed the capacity project for SR 50/Cortez Boulevard, from W of Buck Hope Road to W of Jefferson which has been deferred to FY 2032. She emphasized that FDOT recognizes the need to rehabilitate this section prior to the lane addition project, and it is scheduled for resurfacing in FY 2027 to maintain roadway conditions until the larger project begins. Following the presentation, the Board had no questions or comments.

Presentation by the Florida Turnpike Enterprise on the Tentative Five-Year Work Program (FY 2027-FY 2031)

Katina Kavouklis, from Florida Turnpike Enterprise (FTE) made a presentation on the proposed Tentative Five-Year Work Program for FY 2027-FY 2031. Her presentation included how projects are prioritized and funded.

Commissioner Champion shared that he was recently redirected to the Suncoast Parkway through Citrus County and commended FTE for the excellent design of the off-ramps and nighttime lighting, noting that the project will be a significant economic benefit for both Hernando and Citrus counties in the future.

Ms. Kavouklis responded that customer usage of the facility typically increases by 3-4% when

a new section opens. She agreed to provide Chair Bays, through the MPO staff, with data on facility usage in Citrus County, specifically capturing customers at the facility's entrances and exits, in response to her inquiry.

Presentation by the General Planning Consultant, Benesch & Associates, on the Status of the Congestion Management Process (CMP)

Rob Cursey, the MPO's General Planning Consultant with Benesch & Associates, delivered a presentation detailing the upcoming activities, strategies, and objectives for updating the Congestion Management Process (CMP). He shared that a stakeholder group, primarily composed of members from the Hernando-Citrus MPO's Technical Advisory Committee (TAC), is being assembled and there will be a workshop to gather initial input, coordination, and collaboration with this group on November 20, 2025, at the Hernando County Building Training Facility, 1661 Blaise Drive, Brooksville, Florida. The workshop will be publicly noticed, and members of the public are encouraged to attend.

Mr. Cursey stated that the CMP study focuses on smaller, quick-fix solutions such as intersection improvements, rather than major capacity projects contained in the LRTP. He further explained that existing congestion is often related to intersection-level signal timing, phasing, or geometry. Most recommendations from the study will be operational in nature, providing shorter-term, lower-cost, and implementable solutions that can address current congestion, for example, adjustments to signal timing.

This discussion was in response to Commissioner Champion's comments regarding the lack of signal coordination along SR 50, which contributes to traffic backups. He observed that, unlike Tampa where traffic volumes are higher, uncoordinated red lights along SR 50 can cause vehicles to stop unnecessarily, creating congestion even with relatively minimal traffic.

Presentation by the General Planning Consultant, Benesch & Associates, on the Status of the Complete Streets Update

Chris Keller, AICP, Senior Project Manager at Benesch & Associates, delivered a presentation outlining the goals, objectives, and current status of the Complete Streets update.

Brooksville City Councilman Louis Hallal asked when to submit a request and what data is needed to move a sidewalk project near a school higher on the priority list. Mr. Keller noted that any suggestions will be incorporated into the study.

Commissioner Champion asked if the Complete Streets strategy would change under the new federal administration. Mr. Keller confirmed that while priorities may shift, the core values remain consistent at both the state and federal levels, ensuring safe access and appropriate facilities to provide equal transportation opportunities.

Ms. Ziegler further confirmed that the federal requirement to allocate 2.5% of the MPO planning allotment to Complete Streets has not changed.

## CITIZENS COMMENTS

Hernando County citizens Bob and Shannon Morgan, along with Susie Garfinkle, addressed the Board to voice their concerns and opposition to the proposed Ayers Road Extension Feasibility Study. The study is being conducted to explore options for improving connectivity between the Nature Coast and Interstate 75.

Commissioner Champion commented that while the Ayers Road Extension may or may not be the best solution, he emphasized the county's need for improved access to I-75. Councilman Hallal noted that existing roads already provide connectivity to I-75, citing the route from Ayers Road to Hayman Road, Dan Brown Hill Road, and Spring Lake Highway, which leads directly to the interstate.

## MPO DIRECTOR COMMENTS

Mr. Esposito shared the following updates:

- MPO staff attended the regional meeting of the Florida Metropolitan Planning Partnership (FMPP) on October 22, 2025, and Mr. Esposito attended the Florida Metropolitan Planning Organization (MPOAC) meeting on October 23, 2025.
- The traffic counts for Hernando County began the last week of October and will run through the week of December 11th. Counts will be avoided on November 11th and the week of November 24-28.
- All construction activities associated with the SR 50 widening project from Cobb Road to west of Buck Hope Road have been completed (\$15.8 million project).
- At the October 23rd Citizens Advisory Committee (CAC) meeting, Ron Lawson shared a concern raised by store operators at Mountain Park Plaza, located on SR 50 west of Cobb Road, regarding a "No U-Turn" sign at the intersection of Mobley Road and SR 50. Mr. Esposito thanked the Florida Department of Transportation (FDOT) for responding promptly and removing the sign. FDOT's swift action is greatly appreciated by the local business community.
- In accordance with the adopted UPWP, the MPO Staff completed the annual review of the Continuity of Operations Plan (COOP). This is a safety sensitive document staff utilizes as reference during weather events, health events, and other types of situations that may occur.
- Mr. Esposito will attend the Sun Coast Transportation Planning Alliance (SCTPA) regional meeting on Friday, December 12, 2025. He noted that he would need Commissioner Kinnard to attend or Commissioner Champion as an alternate.
- Mr. Esposito continues discussions with Pasco County, Hernando County, and FDOT on County Line Road. The next Teams call is scheduled for Monday, November 17, 2025.

**WHEREAS**, the City and FDOT desire to enter into a Roadway Transfer Agreement to remove the Roadways from the State Highway System and transfer the Roadways to the City for maintenance and operation; and

**WHEREAS**, FDOT has agreed, as part of the Roadway Transfer Agreement, to construct operational and safety improvements at the intersection of US 98 from N Broad St to east of Jefferson St (FPN 452924-1) to accommodate truck traffic, with construction tentatively planned for FY 2027; and

**WHEREAS**, FDOT has further agreed to resurface US 98/E Jefferson St from west of Cortez Blvd to N Mildred Ave (FPN 449156-1), tentatively planned for FY 2027; and

**WHEREAS**, FDOT agrees to continue maintaining the vehicle bridge (#080001) and related infrastructure over the CSX railroad tracks on N. Broad St; and

**WHEREAS**, the City agrees to maintain the Roadways upon transfer; and

**WHEREAS**, this transfer is mutually agreed upon between FDOT and the City;  
and

**WHEREAS**, the City Council finds that this transfer is in the best interest of the public.

**SECTION FOUR. SEVERABILITY.** If any provision of this Resolution is held invalid by a court of competent jurisdiction, or if any portion becomes preempted by state law, the affected provision shall be deemed stricken and the remainder shall continue in full force and effect.

**SECTION FIVE. EFFECTIVE DATE.** This resolution shall become effective immediately upon adoption.

**THEREFORE**, the DEPARTMENT has agreed to construct operational and safety improvements at the intersection of US 98 from N Broad St to E of Jefferson St (FPN 452924-1) to accommodate truck traffic. The construction is tentatively planned for FY 2027;

The DEPARTMENT agrees to resurface US 98/E Jefferson St from W of Cortez Blvd to N Mildred Ave which is tentatively planned for FY 2027 (FPN: 449156-1);

The DEPARTMENT will file an application with AASHTO to redesignate US 98/N Mildred Ave from Jefferson St to Broad St; US 41/E Jefferson St from US 41/N Broad St to US 98/ Ponce De Leon Blvd; and US 41/Broad St from US 98/Ponce De Leon Blvd to US 41/Jefferson St prior to the execution of the Road Transfer agreement;

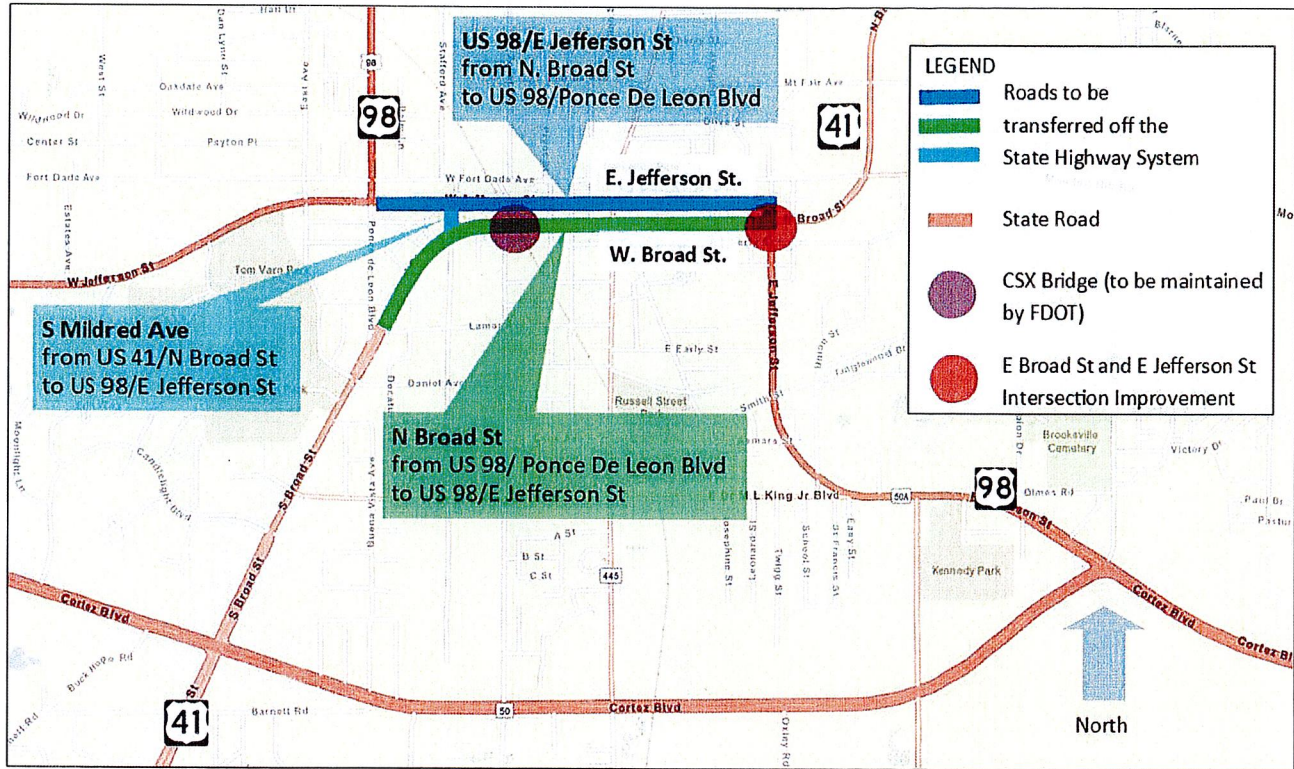

### TITLE

Adoption of the Annual Safety Performance Measures Targets (Highway Safety, PM-1)

### BRIEF OVERVIEW

Metropolitan Planning Organizations (MPOs) are required on an annual basis to establish quality performance measures and targets addressing safety, infrastructure condition, congestion relief, and mobility pursuant to Chapter 490.207(a), [23 CFR 490.209(c)] and 339.175(10), Florida Statutes. The required annual safety performance measures known as PM-1 are as follows:

- Number of fatalities
- Rate of fatalities p/100 million Vehicle Miles Traveled (VMT)
- Number of serious injuries
- Rate of serious injuries p/100 million VMT
- Number of non-motorized fatalities and serious injuries

While the Hernando-Citrus MPO supports FDOT's "Vision Zero" target for traffic related fatalities and serious injuries, and bicycle/pedestrian fatalities and serious injuries in the State of Florida; the MPO Board has historically accepted the State's option allowing for the adoption of its own targets.

Attached are two fact sheets prepared by the Florida Department of Transportation. The first fact sheet provides data specifically about the performance measures of the Hernando-Citrus MPO. The second fact sheet provides data reflecting the MPO/TPO targets statewide. Twenty-one (21) MPOs/TPOs supported the State's Vision Zero target for 2025. Six (6) MPOs/TPOs, including Hernando-Citrus MPO, established specific targets for their planning area while continuing to support the vision of zero fatalities and serious injuries.

The MPO Board adopted the annually required safety performance measures on February 6, 2025, based on a 1% reduction of the 5-year rolling average values. The source of safety data used by MPOs/TPOs to calculate the figures is derived from the Florida Department of Transportation (FDOT). The State has provided the data for 2024 noting that it is preliminary at the time the data was retrieved which was January 20, 2026. The data shown in Table 1 reflects the five-year rolling average for years 2020-2024.

## LEGAL NOTE

Pursuant to Chapter 339.175, Florida Statutes, the Hernando-Citrus MPO Board has the authority to take the recommended action.

## RECOMMENDATION

It is recommended that the MPO Board review and approve the Annual Safety Performance Measures (PM1) targets which are due on February 22, 2026, to the Florida Department of Transportation. It is the MPO Board's decision to either adopt the State's Vision Zero safety targets or utilize the projected 2026 figure based upon a 1% reduction methodology from the prior five-year rolling average.

Federal law requires the Florida Department of Transportation (FDOT), metropolitan planning organizations (MPO), and transit providers to establish and report targets for performance measures that assess road safety, bridge and pavement condition, system performance, transit asset management, and transit safety. FDOT and transit providers establish targets for their planning areas. MPOs may support the targets established by FDOT or the transit providers or establish their own targets for the MPO area. This document summarizes the statewide and MPO targets for the current performance period.

## HIGHWAY PERFORMANCE MEASURES

The Federal Highway Administration (FHWA) established performance measures for: roadway safety, bridge and pavement condition, and system performance.

### SAFETY TARGETS

State DOTs and MPOs must set targets for five performance measures that assess the number and rate of fatalities and serious injuries on all public roads, including specific targets related to vulnerable road users. FDOT established statewide targets in August 2024 for calendar year 2025. Given FDOT's firm belief that every life counts, the statewide target for each safety performance measure is zero. A total of 21 MPOs supported the statewide targets for 2025. Six MPOs established specific targets for their planning area, while continuing to support the vision of zero fatalities and serious injuries. FDOT will set road safety targets for calendar year 2026 in August 2025, after which MPOs will set their targets.

FDOT established statewide targets in December 2022 for pavement condition in 2023 and 2025. All MPOs adopted the statewide targets with the exception of Forward Pinellas, which set higher targets for pavement condition on the non-Interstate portion of the NHS.

FDOT established statewide targets in December 2022 for system performance in 2023 and 2025. A total of 24 MPOs supported all the statewide targets, and three set their own targets for at least one of the measures or years. FDOT revised the 2025 target for the reliability of person-miles traveled on the interstate in October 2024.

## TRANSIT PERFORMANCE MEASURES

The Federal Transit Administration (FTA) established performance measures for transit asset management and public transportation safety and requires certain providers of public transportation to annually establish targets and report performance. Providers must share their targets with each MPO in which provider's projects and services are programmed in the MPO's transportation improvement program (TIP). Those MPOs may either support the provider's targets or also set transit asset management and safety targets for their planning area. Current transit provider and MPO targets may be requested from individual transit providers and MPOs.
