I am concerned for the effect to my driveway and foundation, please do not permit them to be so close and destroy so much.

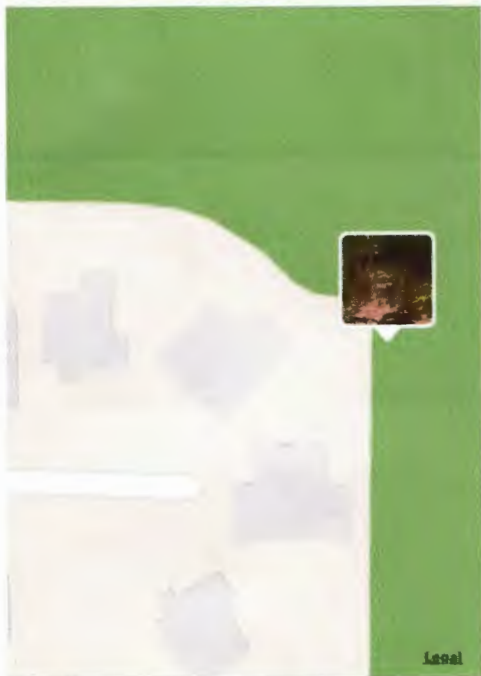
The team was prompt, with Andrew to site, directly after I came to the office today, thanks you guys.

I will be resending pictures next so not to block this initial delivery.

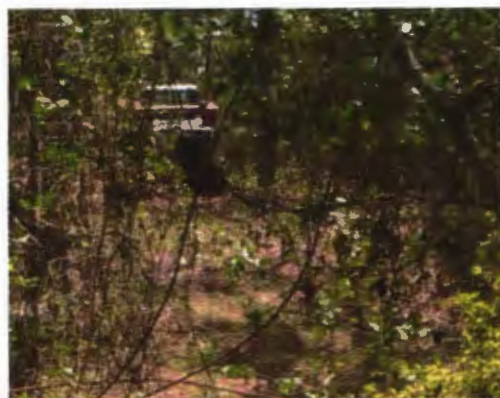
