Award of Sole Source Contract to DEEB Construction and Development Company for Water Main Interconnect From Verano Subdivision to Valley Falls Loop in Wellington Subdivision (Amount: \$71,503.91)

BRIEF OVERVIEW

The Hernando County Utilities Department is requesting Single Source award to Deeb Construction and Development for installation of a new 8-inch water main interconnect for the Wellington Subdivision. This interconnect is identified in the 2021 Water Master Plan. Deeb Construction and Development has been contracted by the developer for the Verano subdivision, to be constructed between Wellington and County Line Road.

Single Source approval and award to Deeb Construction and Development will result in efficiency and cost savings for Hernando County due to Deeb Construction and Development being able to complete the interconnection at the time of construction of the subdivision.

Hernando County Utilities Department has received a quote in the amount of \$71,503.91 from Deeb Construction and Development for this project.
