

RESOLUTION NO. 2025-155

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF HERNANDO COUNTY, FLORIDA, RATIFYING THE COUNTY ADMINISTRATOR'S PREVIOUS SIGNATURE; GRANTING THE COUNTY ADMINISTRATOR SIGNATURE AUTHORITY FOR THE HAZARD MITIGATION GRANT PROGRAM APPLICATION ON BEHALF OF HERNANDO COUNTY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Hernando County has proposed a project for the Hazard Mitigation Grant Program known as "Hernando County Fire Rescue Wind Retrofit", "Hernando County Fire Rescue Generators", "Hernando County Fire Rescue Portable Generator" and "Hernando County Airport Generator" projects ("the Projects"); and

WHEREAS, Hernando County has applied for funding of the Projects through the State of Florida Department of Emergency Management for proposed participation in the Hazard Mitigation Grant Program (FEMA 4828-DR-FL); and

WHEREAS, Hernando County has agreed to provide financial assistance to the Projects in the amount of \$327,604, \$154,860, \$21,258.50 and \$30,943.50, respectively, for storm mitigation activities associated with the Projects, subject to an award(s) of a Hazard Mitigation Grant Program Grant; and

WHEREAS, the Hernando County Board of County Commissioners desires to enter into an agreement to participate in the Hazard Mitigation Grant Program with the State of Florida Department of Emergency Management for the Project.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF HERNANDO COUNTY, FLORIDA:

SECTION 1. The Hernando County Board of County Commissioners hereby ratifies the County Administrator's signature of July 24, 2025, on the associated Hazard Mitigation Grant Program application for the Projects on behalf of Hernando County.

SECTION 2. The County Administrator is further authorized to sign all Hazard Mitigation Grant Program applications on behalf of Hernando County for the Projects and additional documentation as may be requested by the Florida Department of Emergency Management.

SECTION 3. This Resolution shall become effective immediately upon adoption.
