TITLE

Award of Contract to Dr. Robert McPhee for Professional Medical Management Services for Hospital/Outpatient Services for Inmates at Hernando County Jail (Contract No. 21-A00007/CH; Amount: \$66,179.64)

BRIEF OVERVIEW

On July 28, 2015, the Board approved the award of Contract to Dr. Robert J. McPhee for hospital medical management services for the inmates at the County jail. These services provide the management and monitoring of an inmate's hospital stay from admission through discharge to ensure that the inmate is treated only for his/her specific illness/injury. Contract No. 15-R00120/TB expires on September 30, 2020. The County and Sheriff's Office have elected to continue services with Dr. Robert J. McPhee for these services.

The County Department identified as the Project Manager for this file is: Department of Management and Budget (OMB).

The services of the Contract are available for emergency case management twenty-four (24) hours per day seven (7) days per week. The fixed fee per month for these services is \$4,200.00. The County's insurance requirement for professional liability for this contract exceeds Florida Statutes. Therefore, the County reimburses this cost to Dr. McPhee. The cost for Professional Liability for this renewal period is \$15,855.00. Dr. McPhee has elected to pay his premium in 9 installments, a total of \$1,314.97 will be added each month bringing the total monthly expenditure for services to \$5,514.97.

Per Article V - Purchasing Regulations/Procurements Ordinance 93-16, Section 2-101 Application and Exclusions, Item (3), medical services is listed as a procurement exclusion. This Agreement is brought before the Board as an acknowledgement of Medical Services performed by Dr. Robert J. McPhee.

The Chief Procurement Officer has reviewed this requirement for conformance to Procurement Ordinance and Purchasing Policies and Procedures.

It is recommended the Board approve the award of Contract No. 21-A00007/CH to Dr. Robert McPhee, approve and authorize the Chairman's signature on the attached agreement for professional medical management services for hospital/outpatient services for inmates at the Hernando County jail who are transferred to a hospital due to an injury or illness in the amount of \$66,179.64 for an initial one (1) year period. It is further recommended the Board authorize the Chief Procurement Officer to renew the Contract with the same pricing and terms and authorize the Chief Procurement Officer to approve Change Orders and they become necessary and required.
