Here is what was sent out:

The results of our ATV surveys are finally in and we would like to share the results with all of you.

For perspective, the following outlines the number of surveys mailed out, the number which were "undeliverable", and the number completed and submitted by citizens.

• The Hernando County Supervisor of Elections provided us the addresses of every household that had at least one registered voter in precincts 300, 310, 320, and 330.

• 13857 household addresses (with one voter or more) were provided by the Hernando County Supervisor of Elections.

• When those addresses were uploaded to the company that was going to mail the postcards, 96 addresses came back at "non-standard" or incomplete, so a total of 13,761 were mailed.

• So far, 183 have been returned by the United States Postal Service as not deliverable, likely due to the occupants moving and not updating their address with the Supervisor of Elections. Therefore, as of writing of this update, we believe that about 13,578 were actually delivered.

• During the survey period of May 23, 2024 through 12:00 p.m. on June 5, 2024, 1799 surveys were completed and submitted.

• According to <u>https://actionable.com/sample-size-calculator/</u> the following should be fairly accurate analysis of the results.

Population size = 13,584 (P=.5)

With a sample size of 1799,

The confidence interval is greater than 99% (Error +/- 3%)

Question 1 – ATV Enforcement
