## **TEMPORARY CONSTRUCTION EASEMENT**

THIS TEMPORARY CONSTRUCTION EASEMENT, made this 26th day of July , 2022, by and between Wellington at Seven Hills Homeowner's Association, Inc., a Florida corporation, whose address is 400 Wexford Boulevard, Spring Hill, Florida 34609, hereinafter referred to as the "Grantor", and Hernando County Water and Sewer District, a body corporate and politic of the State of Florida, by and through its Board of County Commissioners, whose address is 15470 Flight Path Drive, Brooksville, Florida 34604, hereinafter referred to as the "Grantee".

## WITNESSETH:

The Grantor, in consideration of the sum of Ten Dollars and No Cents (\$10.00) and other good and valuable consideration in hand paid by the said Grantee to the Grantor, receipt and sufficiency of which are hereby acknowledged, hereby grants, gives, bargains and releases to the Grantee, a Temporary Construction Easement, hereinafter referred to as the "Easement", in, upon, over, under, across, along and through the following described real property situated in Hernando County, Florida, to wit:

See Exhibits "A" and "B", attached hereto and made a part hereof by reference.

The Easement granted herein is for the purpose of excavating, constructing, installing, connecting, inspecting, improving and operating public utility facilities, including pipelines, pipes, lines, appurtenances and facilities necessary for the transmission of potable water, upon the land described herein, associated with the Verano Subdivision to Wellington Subdivision Interconnect Project, together with the rights of Ingress and egress in, upon, over, under, across, along and through the adjoining land owned by the Grantor.

It is understood and agreed by the Parties hereto that the rights granted herein shall begin with the date of the Notice to Proceed to the contractor responsible for the Project, a copy of which will be furnished promptly to the Grantor, and shall expire at the end of eighteen (18) months from the date of the Notice to Proceed or upon the recording of a Perpetual Utility Easement for the public utility facilities associated with the Project, whichever occurs last. The land of the Grantor disturbed by the Project shall be restored to its natural grade and condition where topographical features allow upon completion of construction or expiration of this Easement, whichever occurs last.

This Easement shall be recorded in the Public Records of Hernando County, Florida.


