SECOND AMENDMENT TO AVIATION GROUND LEASE (The "SECOND AMENDMENT") BETWEEN HERNANDO COUNTY AND RAYTHEON COMPANY

THIS IS AN AMENDMENT dated March 2, 2009 to the Aviation Ground Lease dated April 1, 2003 between Hernando County, a political subdivision of the State of Florida, whose address is 20 N. Main Street, Room 460, Brooksville, FL 34601 (the "Lessor") and Raytheon Company, whose address is 870 Winter Street, Waltham, MA 02451(the "Lessee").

WHEREAS, the Lessor and the Lessee entered into the Aviation Ground Lease dated as of April 1, 2003, and as recorded in Official Records Book 1650, Pages 454 through 483, of the Public Records of Hernando County, FL (the "Ground Lease") for the lease of certain real property described as:

> 9,000 SF (mol) of the Hernando County Airport land, described as shown in Exhibits A1, A2 & A3, attached to the Ground Lease, as said Exhibits were recorded in the aforesaid Official Records Book at Pages 468 through 470; and,

WHEREAS, the Ground Lease was scheduled to expire on March 30, 2007 and the Lessee and the Lessor agreed to an Amendment to the Aviation Ground Lease (the "First Amendment") extending the Ground Lease for an additional two (2) years running from April 1, 2007, and ending on March 30, 2009; and,

WHEREAS, the Ground Lease and the First Amendment are hereinafter referred to collectively as the Ground Lease; and,

WHEREAS, the Ground Lease is scheduled to expire on March 30, 2009 and Lessee desires to extend the Ground Lease for two (2) additional years; and,

WHEREAS, the Lessee has duly performed under the Ground Lease and is not otherwise in breach of said agreement; and,

WHEREAS, the Lessee has timely advised the Lessor of its intent to renew the Ground Lease.

NOW THEREFORE, in consideration of mutual covenants herein contained, the parties agree as follows:

- 1. The Lessee and the Lessor agree that the Ground Lease is hereby extended for an additional two (2) years commencing on April 1, 2009, and ending on March 30, 2011 (the "Second Extended Term").
- 2. The Monthly Rent during the **Second Extended Term** shall be \$135.00.
- 3. Except as provided above, all other terms, conditions and covenants of the Ground Lease shall remain in full force and effect.
- 4. All capitalized terms not otherwise defined herein shall have the meaning ascribed to them in the Ground Lease.
- 5. This **Second Amendment** shall be recorded in the public records of Hernando County; the Lessee shall pay the cost of recording.
